The Joint Committee met and deliberated on the referral:

## **COMMITTEE REPORT NO. 190-2024**

#### SUBJECT:

"Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on City Disaster Risk Reduction and Management Council Resolution No. 04-2023 "Adopting and Approving the Camp Coordination and Camp Management Plan of Tuguegarao City" for adoption"

#### **ACTION TAKEN:**

The members of the joint committee met to discuss the subject matter with the presence of the resource person/s.

## **FINDINGS:**

- 1.) The City Disaster Risk Reduction and Management Council (CDRRMC) on December 27, 2023 passed CDRRMC Resolution No. 04-2023 "Adopting and Approving the Camp Coordination and Camp Management Plan of Tuguegarao City".
- 2.) Pursuant to the declaration of policies under Republic Act No. 10121 or the Philippine Disaster Risk Reduction and Management Act of 2010, the Department of Social Welfare and Development (DSWD), Department of the Interior and Local Government (DILG), Department of Health (DOH), and Department of Education (DepEd) have issued the Joint Circular No. 02 series of 2021 which enumerates the guidelines on Camp Coordination and Camp Management for Internally Displaced Persons.
- 3.) The Camp Coordination and Camp Management Plan can provide safe and orderly management of evacuation centers of internally displaced individuals, and delivery of basic social services for their immediate recovery.
- 4.) The said plan of the City outlines implementation of pre-emptive and forced evacuation, duties of the evacuation team, evacuation management, inventory of resources, administration, coordinating instruction, and emerging and re-emerging of infectious disease.
- 5.) Adopting and approving the Camp Coordination and Management Plan gives a clear blue print on how the CDRRMC works with its partner agencies and allied forces during disasters.

#### RECOMMENDATION:

After a thorough discussion and perusal of CDRRMC Resolution No. 04-2023 "Adopting and Approving the Camp Coordination and Camp Management Plan of Tuguegarao City", the joint committee recommends for the passage of a City Resolution Adopting and Approving the Camp Coordination and Camp Management Plan of Tuguegarao City.

# CITY RESOLUTION ADOPTING AND APPROVING THE CAMP COORDINATION AND CAMP MANAGEMENT PLAN OF TUGUEGARAO CITY

WHEREAS, Section 16 of Republic Act No. 7160 or the Local Government Code of 1991 provides that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Republic Act No. 10121 otherwise known as Philippine Disaster Risk Reduction and Management Act of 2010, declares a policy enjoining government agencies and instrumentalities to adopt and implement a coherent, comprehensive, integrated, efficient and responsive disaster risk reduction program incorporated in the development plan at various levels of government adhering to the principles of good governance such as transparency and accountability within the context of poverty alleviation and environmental protection;

WHEREAS, the Department of Social Welfare and Development (DSWD), Department of the Interior and Local Government (DILG), Department of Health (DOH), and Department of Education (DepEd) have issued the Joint Circular No. 02 series of 2021 which enumerates the guidelines on Camp Coordination and Camp Management for Internally Displaced Persons;

WHEREAS, pursuant to the said statutory provisions and administrative regulations and in the interest of public service, the Tuguegarao City Government, in consultation with members of the City Disaster Risk Reduction and Management Council (CDRRMC) and other stakeholders, have formulated the Camp Coordination and Camp Management Plan of Tuguegarao City;

**WHEREAS**, the CDRRMC passed Resolution No. 04-2023 titled "Adopting and Approving the Camp Coordination and Camp Management Plan of Tuguegarao City";

WHEREAS, City Mayor, Hon. Maila Rosario S. Ting-Que, endorsed the Camp Coordination and Camp Management Plan of Tuguegarao City to the Ninth City Council for adoption and approval;

WHEREAS, the Camp Coordination and Camp Management Plan can provide safe and orderly management of evacuation centers of internally displaced individuals, and delivery of basic social services for their immediate recovery;

WHEREAS, the Camp Coordination and Camp Management Plan outlines implementation of pre-emptive and forced evacuation, duties of the evacuation team, evacuation management, inventory of resources, administration, coordinating instruction, and emerging and re-emerging of infectious disease;

**WHEREAS**, the Ninth City Council in its 99<sup>th</sup> Regular Session held on July 9, 2024 found the same to be in order and favorably recommended for its adoption and approval.

**NOW**, **THEREFORE**, **RESOLVE**, as it is hereby **RESOLVED**, to adopt and approve the Camp Coordination and Camp Management Plan of Tuguegarao City.
