WHEREAS, HON. MARIA ROSARIO BOLLOZOS SORIANO, City Councilor of Tuguegarao City, has been re-elected as Board Member of the Philippine National Volleyball Federation (PNVF), signifying the continued trust and recognition of her leadership and service by the national volleyball community;

WHEREAS, during her collegiate athletic career with the Ateneo Lady Eagles, she competed in both indoor and beach volleyball, and after completing her playing years from 2003 to 2008, she continued to serve the team as an assistant coach from 2012 to 2014, further demonstrating her dedication to the sport and to athlete development;
