CITY RESOLUTION NO. 192-09-2025

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND GOVERNMENT SERVICE INSURANCE SYSTEM (GSIS) RELATIVE TO THE PROVISION OF A TEMPORARY GSIS SERVICE DESK AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA

WHEREAS, the Government Service Insurance System (GSIS) has a Business Continuity Plan (BCP) as part of its disaster preparedness and risk mitigation in the event of a major disruption (fire, earthquake, flooding, utilities breakdown, etc.) which affects the operations of the GSIS office and hinders it from performing its functions in its current location;

WHEREAS, the GSIS Tuguegarao Branch has identified the Tuguegarao City Government as a possible alternate site where it can set up a temporary GSIS Service Desk to receive applications for claims and loans from GSIS members until the GSIS is able to return to its own office or set up a new location;

WHEREAS, the Tuguegarao City Government is willing to provide a specific area inside its premises to be used as a temporary GSIS Service Desk for the benefit of its members in case a disaster or disruptive event (fire, earthquake, flooding, utilities breakdown, etc.) strikes affecting the operations of the GSIS Tuguegarao Branch Office;

WHEREAS, there is a need for the passage of a resolution granting authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA;

WHEREAS, upon the evaluation of the subject referral, the Committee on Rules, Laws and Ethics recommends for the adoption and approval of the Memorandum of Agreement and the granting of authority to the City Mayor to sign for and on behalf of the Tuguegarao City Government the said MOA;

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement between the Tuguegarao City Government and the Government Service Insurance System (GSIS) relative to the provision of a temporary GSIS Service Desk and to grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.

On motion of Hon. Arugay and without any objection, CITY RESOLUTION NO. 192-09-2025 was APPROVED.
