WHEREAS, Section 106 of the Local Government Code of 1991 provides that each local government unit shall have a comprehensive multisectoral development plan to be initiated by its development council and to be approved by its sanggunian;

WHEREAS, the City Mayor has endorsed to the Ninth City Council CDC Resolution No. 1-2025 titled "*RESOLUTION ENDORSING TO THE AUGUST SANGGUNIAN PANLUNGSOD THE REVISED CY 2025 LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PROGRAM (LDRRMFIP) UNDER THE SUPPORT AND MAINTENANCE TO 24/7 OPERATION CENTER AND AUXILIARY UNIT FOR APPROPRIATE ACTION*" for information and appropriate action;



