MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement executed by and between:

The TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY – REGION II (CAGAYAN VALLEY), an agency of the National Government organized and established under Republic Act No. 7796 otherwise known as the "TESDA Act of 1994," with office address at Regional Office No. II, Carig Norte, Tuguegarao City, Cagayan, represented by its Secretary and Director General, HON. SUHARTO T. MANGUDADATU, PH.D., herein referred to as "FIRST PARTY";

-and-

The LOCAL GOVERNMENT UNIT (LGU) OF TUGUEGARAO CITY, a 3rd class component city and the capital city of the Province of Cagayan, Region II (Cagayan Valley), with its City Hall located at <<u>City/Municipality</u>, Province of Main Campus>, represented herein by its Mayor, HON. MAILA S. TING-QUE, herein referred to as "SECOND PARTY";

WITNESSETH: That,

WHEREAS, there is a need to strengthen the entrepreneurship trainings of the Technical Education and Skills Development Authority (TESDA) in the region in order to maximize the impact of such trainings to local economies, such as the local economy of the capital city of the Province of Cagayan, Tuguegarao City;

WHEREAS, a way to strengthen the said trainings is by providing startup capital to successful completers, particularly the youth, who are citizens of Tuguegarao City;

WHEREAS, supporting the said trainings by providing startup capital to successful completers who are able to submit business plans that are determined to have great potential is aligned with the objective of President Ferdinand Romualdez Marcos Jr. to improve the economy;

WHEREAS, Secretary Suharto T. Mangudadatu includes in his 10-point agenda, under "youthpreneurship or youth entrepreneurship" the need to enhance the entrepreneurship trainings of TESDA in the region in order to maximize its impact, by means of providing startup capital to successful completers, particularly the youth, who are residents of Tuguegarao City;

WHEREAS, the SECOND PARTY has the expertise and resources to provide the said startup capital;

WHEREAS, the SECOND PARTY recognizes that providing the said startup capital to successful completers of the said trainings, particularly the youth, who are citizens of Tuguegarao City will empower the city's youth and boost the city's economy;

WHEREAS, the FIRST PARTY recognizes the need to strengthen the entrepreneurship trainings of TESDA in the region in order to maximize its impact, by means of providing startup capital to successful completers, particularly the youth, who are residents of Tuguegarao City;

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereto hereby agree as follows:

I. ROLES AND RESPONSIBILITIES OF THE PARTIES

1. The FIRST PARTY shall:

- 1.1 For reference, keep a record or registry of the takers and completers of TESDA's entrepreneurship trainings in the region, and always keep the same updated, so as to be properly guided in the selection process of youth residents of Tuguegarao City who are successful completers of the said trainings and whose submitted business plans are determined to have great potential, and deserve to be awarded with the appropriate startup capital by the LGU;
- 1.2 Work closely with the **SECOND PARTY** to establish and sustain for the purpose of this partnership a screening committee comprised of at least six (6) members, which must include competent representatives from the LGU, TESDA, DOLE, DTI, the local Sangguniang Kabataan (SK) Federation, and other appropriate entities depending on the business models and/or plans of the potential recipients;
- 1.3 Work closely with the **SECOND PARTY** in monitoring the progress of the awardees for purposes of impact evaluation, development, additional support as needed and applicable, among other appropriate actions;
- 1.4 Use the title: "NEGOSYANTENG KABATAAN" to refer to this initiative in promotional activities, press releases, among other appropriate activities, for easy labeling and uniformity;
- 2. The SECOND PARTY shall:
 - 2.1 Work closely with the **FIRST PARTY** to establish and sustain for the purpose of this partnership a screening committee comprised of at least six (6) members, which must include competent representatives from the LGU, TESDA, DOLE, DTI, the local SK Federation, and other appropriate entities depending on the business models and/or plans of the potential recipients;
 - 2.2 Ensure that the individuals who have been determined by the said screening committee to be deserving of the startup capital award from the SECOND **PARTY** receives the said appropriate startup capital award, subject to applicable rules and regulations and subject to availability of resources;

- 2.3 Work closely with the **FIRST PARTY** in monitoring the progress of the awardees for purposes of impact evaluation, development, additional support as needed and applicable, among other appropriate actions.
- 2.4 Use the title: "NEGOSYANTENG KABATAAN" to refer to this initiative in promotional activities, press releases, among other appropriate activities, for easy labeling and uniformity;

II. OWNERSHIP OF INTELLECTUAL PROPERTY

In the event that the potential awardees and successful awardees under this Agreement generate unique and noteworthy researches and innovations, the **FIRST PARTY** reserves the right to ownership over the concerned noteworthy researches and innovations for purposes of knowledge management and knowledge creation, in order for the national government to appropriately process the same for maximum national economic benefit and impact.

Both the **FIRST PARTY** and **SECOND PARTY** shall ensure that the partnership arising from this Agreement and its outcome would not violate the intellectual property rights of any third party.

III. TERMINATION AGREEMENT OR NOTICE

The **FIRST PARTY** and **SECOND PARTY** may, based on evidence of failure of either party to comply with the terms of this Agreement, or in the event either party incurs unreasonable delay, inaction, or break of obligation under this Agreement, issue a notice of intent to terminate this Agreement. The **FIRST PARTY** shall give not less than ten (10) days written notice to the **SECOND PARTY** of intent to terminate this Agreement, and vice versa.

If any dispute or difference of any kind whatsoever shall arise between the parties in connection with the implementation or interpretation of this contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

V. SEPARABILITY CLAUSE

In the event that one or more provisions contained herein shall be held invalid, illegal or unenforceable in any respect and for any valid reason, the remaining provisions shall remain valid, legal and enforceable.

VI. EFFECTIVITY

This Agreement shall take effect upon the signing of the Parties involved and shall be renewed every two (2) years.
