**RESOLUTION ADOPTING AND APPROVING CDC RESOLUTION NO. 02-2025 TITLED
“RESOLUTION RECOMMENDING FOR THE CORRECTIONS/AMENDMENTS
OF PROJECT TITLES FOR VARIOUS INFRASTRUCTURE PROJECTS FOR
INCORPORATION IN THE SUPPLEMENTAL LOCAL DEVELOPMENT INVESTMENT
PROGRAM (SLDIP) NO. VIII CY 2023-2028 AND SUPPLEMENTAL ANNUAL
INVESTMENT PROGRAM (SAIP) NO. 1 CY 2025”**

WHEREAS, Section 106 of the Local Government Code of 1991 provides that each local government unit shall have a comprehensive multisectoral development plan to be initiated by its development council and to be approved by its sanggunian;

WHEREAS, the City Mayor has endorsed to the Ninth City Council CDC Resolution No. 02-2025 titled “RESOLUTION RECOMMENDING FOR THE CORRECTIONS/AMENDMENTS OF PROJECT TITLES FOR VARIOUS INFRASTRUCTURE PROJECTS FOR INCORPORATION IN THE SUPPLEMENTAL LOCAL DEVELOPMENT INVESTMENT PROGRAM (SLDIP) NO. VIII CY 2023-2028 AND SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 1 CY 2025 AND ENDORSING THE SAME TO THE AUGUST SANGGUNIAN PANLUNGSOD FOR APPROPRIATE LEGISLATIVE ACTION” for information and appropriate action;

WHEREAS, the members of the Sangguniang Panlungsod through its Committee of the Whole has conducted meetings with the concerned department heads and employees for the discussion of the said CDC Resolution;

WHEREAS, in the said City Development Resolution No. 02-2025, City Engineer Wenceslao Arao Jr. has presented to the City Development Council the list of corrections/amendments of project titles under the approved projects CY 2025 Annual Investment Program as follows:
