“RESOLUTION ENDORSING TO THE AUGUST SANGGUNIANG PANLUNGSOD THE
IDENTIFIED SPECIFIC LOCATIONS OF THE PROJECT INSTALLATION OF
STREETLIGHTS WITHIN CENTRO 03 AND CENTRO 01, TUGUEGARAO CITY”**

WHEREAS, Section 106 of the Local Government Code of 1991 provides that each local government unit shall have a comprehensive multisectoral development plan to be initiated by its development council and to be approved by its sanggunian;

WHEREAS, the City Mayor has endorsed to the Ninth City Council CDC Resolution No. 03-2025 titled “Resolution Endorsing to the August Sangguniang Panlungsod the Identified Specific Locations of the Project Installation of Street Lights within Centro 03 and Centro 01, Tuguegarao City for Appropriate Action” for information and appropriate action;

WHEREAS, the members of the Sangguniang Panlungsod through its Committee of the Whole has conducted meetings with the concerned department heads and employees for the discussion of the said CDC Resolution;

WHEREAS, in the said City Development Resolution No. 02-2025, City Engineer Wenceslao Arao Jr. has presented to the City Development Council the identified specific locations of the project Installation of Streetlights for proper implementation and monitoring, to wit:

WHEREAS, the corresponding Programs of Work were submitted to the Ninth City Council;


