

## AN ORDINANCE NAMING THE PORTION OF LOT DONATED TO BARANGAY LEONARDA INTO KAMAGONG STREET BASED ON BOOK OF THE BIBLE

WHEREAS, Section 13c under the R.A. 7160 or the Local Government Code of 1991, empowers the Local Government Unit (Barangay) full discretion and control over the naming of places within their territorial jurisdiction; in consultation with the National Historical Commission of the Philippines (NHCP);

WHEREAS, in most streets and alleys in Zone 3, Barangay Leonarda, the existing lot donated to the Barangay shall be named "KAMAGONG STREET";

WHEREAS, there is a need to name such existing lot donated to Barangay Leonarda intended for street located at the corner of NARRA STREET and the proposed new street to name "KAMAGONG STREET" in Zone 3, this Barangay, thus, to better identify its location coherence to the community;

WHEREAS, the Sangguniang Barangay Members after a thorough discussion, came up to name the donated lot into "KAMAGONG STREET", as it symbolizes strength in all forms, and is often use as a shade tree along the side of the road, likewise known for one of the indigenous trees to the Philippines;

**NOW THEREFORE**, on motion by Kagawad Susie O. Pamittan and duly seconded by majority of the Sangguniang Barangay members present,

**BE IT ORDAAINED** by the Sangguniang Barangay of Barangay Loenarda, Tuguegarao City, Province of Cagayan.

Section 1. **TITLE OF SCOPE**. This Ordinance shall be known as "AN ORDINANCE NAMING THE PORTION OF LOT DONATED TO BARANGAY LEONARDA INTO KAMAGONG STREET BASED ON BOOK OF THE BIBLE"

Section 2. **DEFINITION OF TERMS**. As used in this ordinance, the following terms shall be construed

1. Street - a public roads typically within houses and buildings on or both sides in the Barangay

2. Alley - a narrow passageway between or behind houses or buildings

Section 3. **Repealing Clause.** All ordinances, rules and regulations or parts thereof, in conflict or inconsistent with any provisions of this ordinance are hereby repealed and/or modified accordingly.

Section 4. Effectivity. This ordinance shall take effect immediately upon its approval.
