The Joint Committee met and deliberated on the referral:

COMMITTEE REPORT NO. 203-2024

SUBJECT:

“Indorsement of City Mayor Hon. Maila Rosario S. Ting-Que on the proposed traffic and rerouting plan including the request for closure of roads, in line with the 2024 Pavyurulun Afi Festival”

Adopted during the 150th JCS - 7/16/2024 session

ACTION TAKEN:

The members of the joint committee met to discuss the subject matter with the presence of the resource person/s.

FINDINGS:

1. Tuguegarao City will be celebrating its 300th Patronal Feast dubbed as "Pavvurulun AFI FESTIVAL 2024," in honor of its Patron Saint, San Jacinto de Polonia, on August 1 to August 16, 2024.
2. The City Mayor, Hon. Maila Rosario S. Ting-Que, has requested for the temporary road closure of the following streets in celebration of this year's Pavvurulun Afi Festival:
 - a) Mabini Street from Corner Aguinaldo Street to Corner Arellano Street on August 1, 2024 from 7 AM to 12 NN for the Opening of the Trade Fair.
 - b) Bonifacio Street from Corners Washington to Arellano Street on August 1, 2024 from 3 PM to 12 MN for the Float Parade.
 - c) Bonifacio Street from Corner Gonzaga Street to Gomez Street on August 3, 2024 from 4 PM to 12 MN for the Pansit Festival.
 - d) Bonifacio Street from Corner Washington Street to Luna Street on August 7, 2024 from 7 AM to 7 PM for the Tunga Na Uto.
 - e) Bonifacio Street from Corner College Avenue to Corner Aguinaldo Street and Two-Way Traffic Flow of Rizal Street from Corner College Avenue to Washington Street on August 10, 2024 from 6 AM to 12 NN the Drum and Lyre Competition.
 - f) Bonifacio Street from Corner College Avenue to Corner Aguinaldo Street, Washington Street from Corner Blumentritt Street to Corner Del Rosario Street, and Two-Way Traffic Flow of Rizal Street from Corner College Avenue to Washington Street on August 14, 2024 from 2 PM to 12 MN in view of the Street Dancing (Light Show).
 - g) College Avenue from Corner Taft Street to Corner Mallillin Street (St. Paul University) on August 16, 2024 from 6 AM to 12 NN for the Patronal Fiesta Eucharistic Celebration at Ermita De San Jacinto.
3. The proposed Traffic and Rerouting Plan aims to establish parking management system, smooth flow of traffic during the activity, provide safety, security, and control measure, and provide traffic monitoring and assistance.
4. The PNP TCCPS will maximize deployment of troops and security for each event and can seek augmentation of forces from the PNP Cagayan 1st Provincial Mobile Force Company and the PNP Regional Mobile Force Battalion.

RECOMMENDATION:

After a thorough discussion, the Joint Committee favorably recommends for the approval of the subject road closures and rerouting plan in view of the conduct of various activities in celebration of the 2024 Pavvurulun Afi Festival, and the passage of an ordinance to that effect.

The Joint Committee further recommends the following:

- a) For the PSSU/TMG to manage traffic and follow rerouting plans during the activities.
- b) Installation of signages regarding the said activity and the road closures/alternate routes.
- c) Early information dissemination through the Tuguegarao City Information Office and other media outlets.

CITY ORDINANCE NO. 24-09-2023

CITY ORDINANCE DECLARING THE TEMPORARY CLOSURE FROM VEHICULAR TRAFFIC AND TWO-WAY TRAFFIC FLOW OF SOME STREETS FOR THE CONDUCT OF VARIOUS ACTIVITIES IN CONNECTION WITH THE CELEBRATION OF THE PAVVURULUN AFI FESTIVAL 2024

WHEREAS, pursuant to the pertinent provisions of Section 21 of Republic Act 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Tuguegarao is authorized to temporarily close some of the local roads falling within its jurisdiction;

WHEREAS, Tuguegarao City will be celebrating its 300th Patronal Feast dubbed as "Pavvurulun AFI FESTIVAL 2024," in honor of its Patron Saint, San Jacinto de Polonia, on August 1 to August 16, 2024;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, has requested for the temporary road closure of some streets and proposed a rerouting plan in view of the conduct of various activities in celebration of this year's Pavvurulun Afi Festival;

WHEREAS, the Traffic and Rerouting Plan aims to establish parking management system, smooth flow of traffic during the activity, provide safety, security, and control measure, and provide traffic monitoring and assistance;

WHEREAS, the Ninth City Council in its 100th Regular Session held on July 16, 2024, taking in mind public safety and security, found the request to be in order, with merit and beneficial to the constituents of Tuguegarao City, hence recommended for its approval.

NOW, THEREFORE, be it **ORDAINED**, by the Ninth City Council in session assembled to enact the following ordinance:

SECTION 1. TITLE. This Ordinance shall be known as ***“CITY ORDINANCE DECLARING THE TEMPORARY CLOSURE FROM VEHICULAR TRAFFIC AND TWO-WAY TRAFFIC FLOW OF SOME STREETS FOR THE CONDUCT OF VARIOUS ACTIVITIES IN CONNECTION WITH THE CELEBRATION OF THE PAVVURULUN AFI FESTIVAL 2024”***

SECTION 2. SCOPE AND LIMITATION. This Ordinance shall cover the following roads and on specified dates:

- a) Mabini Street from Corner Aguinaldo Street to Corner Arellano Street on August 1, 2024 from 7 AM to 12 NN for the Opening of the Trade Fair.
- b) Bonifacio Street from Corners Washington to Arellano Street on August 1, 2024 from 3 PM to 12 MN for the Float Parade.
- c) Bonifacio Street from Corner Gonzaga Street to Gomez Street on August 3, 2024 from 4 PM to 12 MN for the Pansit Festival.
- d) Bonifacio Street from Corner Washington Street to Luna Street on August 7, 2024 from 7 AM to 7 PM for the Tunga Na Uto.
- e) Bonifacio Street from Corner College Avenue to Corner Aguinaldo Street and Two-Way Traffic Flow of Rizal Street from Corner College Avenue to Washington Street on August 10, 2024 from 6 AM to 12 NN the Drum and Lyre Competition.
- f) Bonifacio Street from Corner College Avenue to Corner Aguinaldo Street, Washington Street from Corner Blumentritt Street to Corner Del Rosario Street, and Two-Way Traffic Flow of Rizal Street from Corner College Avenue to Washington Street on August 14, 2024 from 2 PM to 12 MN in view of the Street Dancing (Light Show).

- g) College Avenue from Corner Taft Street to Corner Mallillin Street (St. Paul University) on August 16, 2024 from 6 AM to 12 NN for the Patronal Fiesta Eucharistic Celebration at Ermita De San Jacinto.

SECTION 3. INFORMATION. This Ordinance shall be disseminated through signages and all mass media outlets in Tuguegarao City including the Facebook Page of Tuguegarao City Information Office.

SECTION 4. IMPLEMENTATION. This Ordinance shall be implemented by the Local Chief Executive through the Public Safety and Security Office (PSSO) in coordination with the Office of the City Chief of Police, City General Services Office and City Information Office.

SECTION 5. EFFECTIVITY. This Ordinance shall take effect on August 01, 2024 to August 16, 2024.
