RESOLUTION ADOPTING AND APPROVING CDC RESOLUTION NO. 06-2025 TITLED "CITY DEVELOPMENT COUNCIL RESOLUTION ADOPTING AND ENDORSING TO THE AUGUST SANGGUNIANG PANLUNGSOD THE HEREIN ATTACHED SUPPLEMENTAL LOCAL DEVELOPMENT INVESTMENT PROGRAM (SLDIP) NO. VIII CY 2023-2028 FOR APPROPRIATE ACTION"

WHEREAS, Section 106 of the Local Government Code of 1991 provides that each local government unit shall have a comprehensive multisectoral development plan to be initiated by its development council and to be approved by its sanggunian;

WHEREAS, the City Mayor has endorsed to the Ninth City Council CDC Resolution No. 06-2025, titled "CITY DEVELOPMENT COUNCIL RESOLUTION ADOPTING AND ENDORSING TO THE AUGUST SANGGUNIANG PANLUNGSOD THE HEREIN ATTACHED SUPPLEMENTAL LOCAL DEVELOPMENT INVESTMENT PROGRAM (SLDIP) NO. VIII CY 2023-2028 FOR APPROPRIATE ACTION" for information and appropriate action;

WHEREAS, the members of the Sangguniang Panlungsod through its Committee of the Whole have conducted meetings with the concerned department heads and employees for the discussion of the said CDC Resolution;

WHEREAS, there are increases in some of the budgetary amounts of priority programs and projects in the approved LDIP 2023-2028;

WHEREAS, there were new priority programs and projects which were not included in the approved LDIP 2023-2028 and PPAs that were manifested during the conference which needed funding and implementation;

WHEREAS, there is a need to integrate these priority programs, projects and activities, and other items of expenditures in the LDIP as supplements thereof for efficiency and effectiveness of services and needed facilities of the local government unit of Tuguegarao City;

WHEREAS, finding the said CDC Resolution to be in order and beneficial to the constituents of Tuguegarao City, the Ninth City Council during its Special Session held on March 24, 2025 adopted and approved Committee of the Whole Report No. 94-2025 adopting and approving CDC Resolution No. 06-2025 titled "CITY DEVELOPMENT COUNCIL RESOLUTION ADOPTING AND ENDORSING TO THE AUGUST SANGGUNIANG PANLUNGSOD THE HEREIN ATTACHED SUPPLEMENTAL LOCAL DEVELOPMENT INVESTMENT PROGRAM (SLDIP) NO. VIII CY 2023-2028 FOR APPROPRIATE ACTION."
