**RESOLUTION EARNESTLY REQUESTING THE PROVINCIAL GOVERNMENT OF
CAGAYAN THROUGH THE PROVINCIAL GOVERNOR, HON. EDGAR
“MANONG EGAY” BATALLA AGLIPAY, TO EXTEND THE OPERATING HOURS
OF THE CAGAYAN SPORTS COMPLEX UP TO 9:00 IN THE EVENING**

WHEREAS, the Cagayan Sports Complex, located in Tuguegarao City, serves as the primary sports and recreational facility in the province, providing a safe and accessible venue for athletes, runners, and fitness enthusiasts to train and engage in various physical activities;

WHEREAS, the facility is currently open only until 7:00 in the evening, which poses challenges for athletes who train, as well as for working individuals, particularly those employed in government and private institutions, who are unable to use the facility after their office hours;

WHEREAS, extending the operating hours up to 9:00 in the evening would provide more opportunities for both athletes and the general public to engage in regular physical exercise and sports activities, thereby promoting health, wellness, and work-life balance among residents of Tuguegarao City and neighboring municipalities;

WHEREAS, numerous running and fitness groups in the city have expressed their desire to use the Cagayan Sports Complex beyond its current operating hours, citing that cooler weather and lighter traffic in the evening create a safer and more comfortable conditions for training and recreation;

WHEREAS, the Provincial Government of Cagayan has consistently demonstrated its commitment to sports development and public welfare, and the proposed extension of the operating hours aligns with its advocacy to promote physical fitness, discipline, and community engagement through sports;



WHEREAS, the Tuguegarao City Government fully supports initiatives that enhance the quality of life and well-being of its constituents by ensuring continued access to safe, well-maintained, and inclusive public facilities for recreation and fitness;

WHEREAS, the extension of the complex’s operating hours can be implemented with minimal additional resources while providing significant benefits to athletes, fitness enthusiasts, and the general public;




RESOLVED FURTHER, to furnish a copy of this Resolution to the Office of the Provincial Governor and other concerned offices for their information and favorable consideration.
