## CITY RESOLUTION NO. 209-10-2025

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT
BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE PROVINCIAL
GOVERNMENT OF CAGAYAN RELATIVE TO THE DEVELOPMENT ASSISTANCE
TO LGUS – NO TOWN LEFT BEHIND (FUND TRANSFER) IN THE AMOUNT
OF THREE MILLION PESOS (P3,000,000.00) AND GRANTING AUTHORITY TO
THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE,
TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY
GOVERNMENT THE SAID MOA

WHEREAS, Section 455 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, grants the power to the Local Chief Executive to enter into contracts on behalf of the local government unit with prior authorization by the Sanggunian concerned;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, requested the Tenth City Council for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Provincial Government of Cagayan relative to the Development Assistance to LGUs – No Town Left Behind (Fund Transfer) in the amount of Three Million Pesos (P3,000,000.00);

**WHEREAS**, the Provincial Government of Cagayan is extending financial assistance amounting to Three Million Pesos (P3,000,000.00) funded under the CY 2025 Development Assistance to LGUs – No

Town Left Behind (NTLB) (Fund Transfer) of the Province to the Tuguegarao City Government which shall be utilized for the implementation of the identified priority infrastructure project of the City;

WHEREAS, the said Memorandum of Agreement establishes the terms and conditions governing the transfer of funds from the Provincial Government of Cagayan to Tuguegarao City the aggregate amount of Three Million Pesos (P3,000,000.00) as an implementation of the CY 2025 Development Assistance to LGUs – No Town Left Behind (NTLB) (Fund Transfer) to be utilized for the Concreting with Drainage Component of Lansones Street, San Gabriel, Tuguegarao City;

WHEREAS, the Tenth City Council, during the 19<sup>th</sup> Regular Session held on November 13, 2025, found the terms and conditions of the MOA to be beneficial and meritorious and deemed it proper to approve the herein resolution;

WHEREAS, the Tenth City Council emphasized that the Memorandum of Agreement should be signed by the Governor and not by the Provincial Administrator, pursuant to Section 465 (vi)(b)(1) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, which provides that the provincial governor "shall represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance";

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to approve the Memorandum of Agreement between the Tuguegarao City Government and the Provincial Government of Cagayan relative to the Development Assistance to LGUs – No Town Left Behind (NTLB) (Fund Transfer) in the amount of Three Million Pesos (P3,000,000.00) and grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.

**RESOLVED FURTHER**, to furnish copies of this resolution to the Provincial Government of Cagayan for information.
