## CITY RESOLUTION NO. 210-10-2025

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE PROVINCIAL GOVERNMENT OF CAGAYAN RELATIVE TO THE FUND TRANSFER FOR THE SUPPORT TO LGU AGRICULTURAL PROGRAMS IN THE AMOUNT OF THREE MILLION PESOS (P3,000,000.00) AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA

WHEREAS, Section 455 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, grants the power to the Local Chief Executive to enter into contracts on behalf of the local government unit with prior authorization by the Sanggunian concerned;

WHEREAS, Republic Act No. 11321, otherwise known as the "Sagip Saka Act," institutionalizes the Farmers and Fisherfolk Enterprise Development Program (FFEDP) which seeks to improve the income of farmers and fisherfolk through productivity enhancement, market access, and enterprise development;

WHEREAS, Department of Agriculture Administrative Circular No. 08, Series of 2019 "The Implementing Rules and Regulations of Republic Act No. 11321 "An Act Instituting the Farmers and Fisherfolk Enterprise Development Program of the Department of Agriculture" encourages the cooperation

of national government agencies and local government units (LGUs) in implementing projects and activities that support agricultural and fishery enterprises;

WHEREAS, Section 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers local government units to discharge functions and responsibilities for the general of their constituents, including agricultural development programs;

WHEREAS, Section 25(b) of the same Code provides that the Provincial Government shall ensure that city governments act within the scope of their prescribed powers and functions, and may provide financial, technical, or material assistance to component cities when necessary;

WHEREAS, pursuant to the foregoing, the Provincial Government of Cagayan has allocated funds under its Supplemental Budget No. 1 for the Year 2025 for the implementation of the Fund Transfer for the Support to LGU Agricultural Programs to support agricultural productivity and market linkage initiatives in component cities/municipalities with an allocated amount of Three Million Pesos (P3,000,000.00) per municipality and city;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, requested the Tenth City Council for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Provincial Government of Cagayan relative to the Fund Transfer for the support to LGU Agricultural Programs in the amount of Three Million Pesos (P3,000,000.00);

WHEREAS, the said Memorandum of Agreement establishes the terms and conditions governing the transfer of funds from the Provincial Government of Cagayan to Tuguegarao City the aggregate amount of Three Million Pesos (P3,000,000.00) as an implementation of the Fund Transfer for the Support to LGU Agricultural Programs and must be utilized for buying and selling of Palay and other agricultural produce and/or agriculture related products;

**WHEREAS**, the Tenth City Council, during its 19<sup>th</sup> Regular Session held on November 13, 2025, found the terms and conditions of the MOA to be beneficial and meritorious and deemed it proper to approve the herein resolution;

WHEREAS, the Tenth City Council emphasized that the Memorandum of Agreement should be signed by the Governor and not by the Provincial Administrator, pursuant to Section 465 (vi)(b)(1) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, which provides that the provincial governor "shall represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance";

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to approve the Memorandum of Agreement between the Tuguegarao City Government and the Provincial Government of Cagayan relative to the Fund Transfer for the support to LGU Agricultural Programs in the amount of Three Million Pesos (P3,000,000.00) and grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.

**RESOLVED FURTHER**, to furnish copies of this resolution to the Provincial Government of Cagayan for information.

On motion of Hon. Baccay, duly seconded and without any objection, CITY RESOLUTION NO. 210-10-2025 was APPROVED under suspended rules.
