### CITY RESOLUTION NO. 210-09-2025

# RESOLUTION DENYING THE REQUEST OF SCHEDULED PLAYDATES OF THE DUPAYA RECREATION CENTER ON JUNE 2, 4, 9, 11, 16, 18, 23, 25 AND 30, 2025

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, indorsed to the Ninth City Council the request of the Dupaya Recreation Center, Inc. to hold special cockfights on various dates for the month of March 2025;

WHEREAS, Section 10(D) of City Ordinance No. 32-08-2019 states that the City Mayor may issue permits for special cockfights, cock or stag derbies including cockfights via satellite participated in by cockers and breeders through invitations upon application duly approved by the Sangguniang Panlungsod through resolution of 30-working days before the scheduled playdate and that the authority to hold special cockfights or derbies and Barangay sponsored cockfights should always be covered by a Resolution of the Sangguniang Panlungsod and the Mayor's Permit;

WHEREAS, the holding of special cockfights must adhere to strict compliance of City Ordinance No. 32-08-2019 and the failure of the Dupaya Recreation Center, Inc. to secure special permit from the Office of the City Mayor in the conduct of special cockfights shall cause the recall of the resolution approving the conduct of such special cockfights;

WHEREAS, the indorsement was included in the 131st Regular Session held on March 25, 2025 and was referred to the Committee on Games, Entertainment and Amusement for proper action;

**WHEREAS**, Committee Report No. 96-2025 of the Committee on Games, Entertainment and Amusement was deliberated during the 132<sup>nd</sup> Regular Session held on April 07, 2025;

**WHEREAS**, some members of the Ninth City Council asked and clarified about the justifications on the holding of Hackfights (Ulutan);

WHEREAS, the matter was put into votation through secret balloting.

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to deny the request of the Dupaya Recreation Center to conduct Hackfights (Ulutan) on June 2, 4, 9, 11, 16, 18, 23, 25 and 30, 2025.
