CITY RESOLUTION NO. 211-10-2025

**RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT
BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND PADILLA-VILLASIS
OPTOMETRIC CLINIC RELATIVE TO THE APPLICATION FOR
PHILHEALTH OPTOMETRIC BENEFIT PACKAGE AND GRANTING
AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE,
TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY
GOVERNMENT THE SAID MOA**

WHEREAS, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, grants the power to the Local Chief Executive to enter into contracts on behalf of the local government unit with prior authorization by the Sanggunian concerned;

WHEREAS, the referral *“Indorsement of the City Administrator, Mr. Juanito A. Calubaquib, on the draft Memorandum of Agreement between the Tuguegarao City Government and Padilla-Villasis Optometric Clinic relative to the application for PhilHealth Optometric Benefit Package”* was endorsed to the Tenth City Council;

WHEREAS, the Tuguegarao City Government recognizes the importance of ensuring access to quality and affordable eye care services for its constituents, particularly the indigent and underprivileged sectors of society;

WHEREAS, the Tuguegarao City Government, through its City Health Office, intends to partner with Padilla-Villasis Optometric Clinic, a duly licensed and accredited eye care provider, for the implementation and availment of the said PhilHealth benefit package;

WHEREAS, the said draft Memorandum of Agreement is in pursuance of PhilHealth Memorandum Circular No. 2025-0002, otherwise known as the *PhilHealth Benefit Package for Optometric Services for Children 0 to 15 Years Old* which seeks to promote early detection and management of visual impairments among children, ensuring better eye health outcomes through accessible and affordable optometric care;

WHEREAS, Section V-B, Paragraph 2d of the said circular, provides that health facilities shall have a Memorandum of Agreement with PhilHealth Konsulta Package Provider or schools conducting vision screening based on Republic Act No. 11358 (National Vision Screening Act) act referral facilities for optometric services;

WHEREAS, in order to make the contract legally binding, it is necessary to approve the Memorandum of Agreement between the Tuguegarao City Government and Padilla-Villasis Optometric Clinic relative to the application for PhilHealth Optometric Benefit Package;

WHEREAS, upon review of the subject referral and finding the same to be in order and beneficial for Tuguegarao City, the Joint Committee on Health and Sanitation and Committee on Rules, Laws and Ethics recommended for the approval of the said Memorandum of Agreement;


