RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE DEPARTMENT OF HEALTH-CAGAYAN VALLEY CENTER FOR HEALTH DEVELOPMENT (DOH-CVCHD) RELATIVE TO THE REFERRAL OF COVID-19 SPECIMENS FOR THE PERIOD 2025-2027 AND AUTHORIZING THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA

WHEREAS, the Department of Health-Cagayan Valley Center for Health Development (DOH-CVCHD) plays a crucial role in the health and safety of communities in the Cagayan Valley region, especially during public health emergencies such as the COVID-19 pandemic;

WHEREAS, the Tuguegarao City Government recognizes the importance of collaborating with DOH-CVCHD to strengthen its response to the COVID-19 pandemic and ensure the timely referral, testing, and accurate results for COVID-19 specimens collected from local residents;

WHEREAS, both parties have drafted a Memorandum of Agreement (MOA) to formalize their collaboration in the referral of COVID-19 specimens for testing and other related health services, which aims to ensure the proper coordination and smooth implementation of activities for the period of 2025-2027;

WHEREAS, the draft MOA sets forth the roles and responsibilities of both the Tuguegarao City Government and DOH-CVCHD, including but not limited to the proper handling, transportation, and timely testing of specimens, as well as the provision of technical support and resources by both parties.

NOW, **THEREFORE**, **RESOLVE**, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement between the Tuguegarao City Government and the Department of Health-Cagayan Valley Center for Health Development (DOH-CVCHD) relative to the referral of COVID-19 specimens for the
