**WHEREAS**, the Tuguegarao City Government acknowledges its commendable young citizens who have brought home distinctions and honors, worthy of admiration and merit;



**RESOLVED FURTHER**, to furnish a copy of this Resolution to Ms. Obret Maria Battung Calubaquib for her information.


