WHEREAS, the late former Senate President and former Chief Presidential Legal Counsel,
HONORABLE JUAN PONCE ENRILE peacefully joined his Creator on November 13, 2025;

WHEREAS, former Senate President and former Chief Presidential Legal Counsel
HONORABLE JUAN PONCE ENRILE has served the country in various capacities, using his legal
expertise and vast knowledge in creating important laws and helping ensure the government in effective
implementation of policies related to revenue generation, the economy, peace and order, national defense
and social services;

WHEREAS, the centenarian former Senate President has dedicated his life to public service as Finance Secretary and acting Chairman of the Monetary Board (1966-1968), Justice Secretary (1968-1970), Defense Secretary (1970-1986), Batasang Pambansa Parliamentarian (1978-1986), Senator (1987-1992, 1995-2001, 2004-2010 and 2010-2016), and as 1st District of Cagayan Representative at the House of Representatives (1992-1995);

WHEREAS, former Senate President Juan Ponce Enrile made significant contributions and accomplishments which have shaped and paved way to the progress and development of the Province of Cagayan;

WHEREAS, former Senate President Enrile authored the Charter of Cagayan State University and the Cagayan Special Economic Zone Act of 1995 (CEZA), and was instrumental in the conversion of Municipality of Tuguegarao into a Component City making Tuguegarao City as the Regional Center of Region 02;

WHEREAS, former Senate President Juan Ponce Enrile built a legacy that would be remembered and enjoyed by many Cagayano generations;

WHEREAS, the former Senate President or Manong Johnny as he is often called secured a prominent place in the pages of Philippine History when as Defense Minister, he and then Armed Forces Vice Chief of Staff Fidel V. Ramos led the 1986 bloodless EDSA People Power Revolution;

WHEREAS, Manong Johnny as former Senate President also showed his brilliance and legal acumen as Presiding Officer during the 2012 impeachment trial of the Supreme Court Justice Renato Corona;

WHEREAS, the former Senate President deserves the nation's commendation and a snappy salute for his incomparable performance as a public servant, as well as his contribution to the country and the Filipino people which are worthy of emulation of the present and future generations;

WHEREAS, the passing of the late former Senate President Juan Ponce Enrile is a great loss not only to his family and friends but to the people of Cagayan and the Filipino people from whom he had served as a devoted public official and successful businessman ever committed to public interest in the performance of his official duties with utmost dedication and professionalism;




