**WHEREAS**, the Supreme Court of the Philippines through Supreme Court En Banc Resolution A. M. No. 24-02-18-SC dated February 27, 2024 established the Office of the Regional Court Manager (ORCM) as part of the Judiciary’s modernization efforts under the Strategic Plan for Judicial Innovations 2022-2027;

**WHEREAS**, the creation of the Office of the Regional Court Manager (ORCM) aims to further enhance the efficiency and effectiveness of the judiciary by delegating specific functions from the Office of the Court Administrator to the Office of the Regional Court Manager (ORCM);



**WHEREAS**, the Ninth City during its regular session dated April 07, 2025 approved City Resolution No. 208-09-2025 titled “Resolution Approving the Memorandum of Agreement between the Tuguegarao City Government and Supreme Court of the Philippines, through the Court Administrator, Regarding the Establishment of the Office of the Regional Court Manager and Granting Authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to Sign for and on Behalf of the Tuguegarao City Government the said MOA;

**WHEREAS**, on October 30, 2025, the Supreme Court of the Philippines appointed Honorable Atty. Norman Clarence T. Lasam as the First Regional Court Manager of the Second Judicial Region;

**WHEREAS**, as the Regional Court Manager of the Second Judicial Region, **HONORABLE ATTY. NORMAN CLARENCE T. LASAM** is in-charge of directly coordinating with the court branches within the region, covering the provinces of Cagayan, Batanes, Ifugao, Isabela, Kalinga-Apayao, Nueva Vizcaya and Quirino;

**WHEREAS**, **HONORABLE ATTY. NORMAN CLARENCE T. LASAM** is a resident of Barangay Pengue-Ruyu, Tuguegarao City and the son of the late Atty. Ephraim Z. Lasam and Mrs. Rosemarie T. Lasam;

**WHEREAS**, **HONORABLE ATTY. NORMAN CLARENCE T. LASAM** finished his secondary school at the Cagayan National High School as the Class Valedictorian in 2003;

**WHEREAS**, **HONORABLE ATTY. NORMAN CLARENCE T. LASAM** finished Bachelor’s Degree in Business Administration from the University of the Philippines Diliman, Cum Laude, and later obtained his Juris Doctor Degree from the University of the Philippines (UP) College of Law where he successfully passed the 2013 Philippine Bar Examinations;

**WHEREAS**, prior to his appointment as the Regional Court Manager of the Second Judicial Region, Honorable Norman Clarence T. Lasam was the Dean of Cagayan State University – College of Law (CSU) from 2022 to 2025, as well as the Director of the Intellectual Property Management Office (IPMO).

**WHEREAS**, **HONORABLE ATTY. NORMAN CLARENCE T. LASAM** served as the Coach of the CSU Moot Court Team which became a finalist to the Stetson International Environmental Law Moot Court Competition in 2017 and a quarterfinalist at the Nuremberg Moot Court Competition 2019 and 2023;

**WHEREAS**, the appointment of **HONORABLE ATTY. NORMAN CLARENCE T. LASAM** as the First Regional Court Manager of the Second Judicial Region is a testament of his exemplary qualifications, leadership, dedication, integrity and unwavering commitment to public service that will serve as an inspiration not only to the legal community but as well as to his fellow Tuguegaraoños;

**WHEREAS**, the Tuguegarao City Government deems it fitting to commend **HONORABLE ATTY. NORMAN CLARENCE T. LASAM** for being appointed the First Regional Court Manager of the Second Judicial Region;




**RESOLVED FURTHER**, to furnish a copy of this resolution to Honorable Atty. Norman Clarence T. Lasam for his information.


