CITY RESOLUTION NO. 216-09-2025

**RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN
THE TUGUEGARAO CITY GOVERNMENT AND THE CAGAYAN VALLEY
CENTER FOR HEALTH DEVELOPMENT (CVCHD) RELATIVE TO THE USE
OF OFFICE SPACE WITHIN THE VICINITY OF CITY HALL FOR SENIOR
CITIZENS OF TUGUEGARAO CITY AND AUTHORIZING THE CITY MAYOR,
HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF
OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA**

WHEREAS, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code, grants the power to the Local Chief Executive to enter into contracts on behalf of the local government unit with prior authorization by the Sangguniang Panlungsod;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, requested for an authority to represent, enter and sign for and on behalf of the Tuguegarao City Government the draft Memorandum of Agreement between the Tuguegarao City Government and Cagayan Valley Center for Health Development (CVCHD) relative to the use of office space within the vicinity of City Hall for senior citizens of Tuguegarao City;

WHEREAS, the Tuguegarao City Government acknowledges the significant role to contributions of senior citizens and is committed to promoting their welfare and access to essential services;

WHEREAS, the CVCHD is in need of office space to accommodate the operations of the Senior Daycare Health and Wellness Center accordingly, the Tuguegarao City Government has granted permission for the use of the 2nd floor of the Office for Senior Citizens Affairs (OSCA) for this purpose;

WHEREAS, a Memorandum of Agreement (MOA) between the Tuguegarao City Government and the CVCHD has been drafted to formally establish the terms and conditions governing the matter;

WHEREAS, the Federation of Senior Citizens Association of Tuguegarao City has submitted a Certificate of No Objection to the use of said office space;

WHEREAS, the Sangguniang Panlungsod, upon review, finds the MOA consistent with the City’s commitment to inclusive governance and the promotion of senior citizen welfare.


NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement between the Tuguegarao City Government and the Cagayan Valley Center for Health Development (CVCHD) relative to the use of office space within the vicinity of City Hall for senior citizens of Tuguegarao City and to grant authority to the City Mayor, Hon.
