**SUBJECT:**

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the request of the Dupaya Recreation Center, Inc. to hold special derbies on the various dates for the month of October 2024.

**FINDINGS:**

1. The City Mayor, Hon. Maila Rosario S. Ting-Que, indorsed to the Ninth City Council the request of the Dupaya Recreation Center, Inc. to hold special derbies on various dates for the month of October 2024.
2. Section 10, Paragraph D of City Ordinance No. 32-08-2019 states that the City Mayor may issue permits for special cockfights, cock or stag derbies including cockfights via satellite participated in by cockers and breeders through invitations upon application duly approved by the Sangguniang Panlungsod through a resolution **30-working days** before the scheduled playdate.
3. Hon. Jude T. Bayona, manifested that the council already amended the cockfighting ordinance to include the use of betting machine in the conduct of special derbies and usual derby done every Sunday.
4. During its 100<sup>th</sup> regular session, the council approved the request of Dupaya Recreation Center, Inc. for the usage of betting machine in their conduct of special derbies & regular derby.


5. City Treasurer, Mr. Buenaventura F. Lagundi, manifested that they are ready for the certain fees to be collected in accordance to the approved request of the Dupaya Recreation Center, Inc. for the use of betting machine and to the amended cockfighting ordinance.
