### RESOLUTION RECONSIDERING CITY RESOLUTION NO. 210-09-2025 DENYING THE REQUEST OF SCHEDULED PLAY DATES OF THE DUPAYA RECREATION CENTER FOR THE MONTH OF JUNE 2025

WHEREAS, the Committee on Games, Entertainment and Amusement met and deliberated last April 03, 2025 to discuss the Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the request of Ms. Elizabeth G. Dupaya relative to the holding of hackfights (Ulutan) for the month of June;

WHEREAS, after a thorough discussion and finding the request to be advantageous to the Tuguegarao City Government, the committee recommended for the approval of the request of Ms. Elizabeth G. Dupaya to hold special cockfights on June 2, 4, 9, 11, 16, 18, 23, 25 and 30, 2025, as contained in Committee Report No. 96-2025 which was included in the agenda held on April 07, 2025 for its final approval;

**WHEREAS**, during the said 132<sup>nd</sup> Regular Session, the approval for the scheduled play dates was denied;

WHEREAS, the Owner/Operator of the Dupaya Recreation Center, Mr. Elizabeth G. Dupaya, endorsed a letter requesting for the reconsideration of City Resolution No. 210-09-2025 denying the request of scheduled play dates of the Dupaya Recreation Center for the month of June 2025;

**WHEREAS**, the Joint Committee on Games, Entertainment and Amusement and Committee on Rules, Laws and Ethics met and deliberated last April 23, 2025 to discuss the said matter;

WHEREAS, after the discussion of the said request, the joint committees approved the scheduled play dates on June 9, 11, 16, 19, 23, 25 and 30, 2025 and denied the scheduled play dates on June 2 and 4, 2025 due to violation of City Ordinance No. 32-08-2019;

**NOW, THEREFORE, RESOLVE,** as it is hereby **RESOLVED**, to reconsider City Resolution No. 210-09-2025 denying the request of scheduled play dates of the Dupaya Recreation Center for the month of June 2025.
