**INDORSEMENT OF THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, ON THE DRAFT MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND SAINT PAUL UNIVERSITY PHILIPPINES RELATIVE TO THE ON-THE-JOB TRAINING OF ITS BACHELOR OF SCIENCE IN ENVIRONMENTAL SANITARY ENGINEERING STUDENT.**

**ACTIONS TAKEN AND FINDINGS:**

1. The City Mayor Hon. Maila Rosario S. Ting-Que indorsed to the Ninth City Council her request for an authority to represent, enter and sign for and on behalf of the Tuguegarao City Government the draft Memorandum of Agreement with Saint Paul University Philippines (SPUP) relative to the On-Job-Training of its Bachelor of Science in Environmental Sanitary Engineering student.
2. The City Vice-Mayor, Presiding Officer referred the matter to the Committee of the Whole for Consideration.

3. The Committee of the Whole met and discussed the matter and found out that the City Mayor subsequently indorsed a Letter August 14, 2024 of Engr. Christian Cabauatan and Dr. Marifel Grace Capili Kummer of Saint Paul University of the Philippines informing the Tuguegarao City Government on the withdrawal of the intent to deploy Ms. Jenny Joy S. Teppang, a Bachelor of Science in Environmental Sanitary Engineering student, as intern.

**RECOMMENDATION:**

With the withdrawal of said endorsement and with the reasons stated in the Letter dated August 14, 2024 , the Committee of the Whole recommends to consider the subject indorsement as moot and academic.
