RESOLUTION APPROVING THE CONTRACT OF SERVICE TO BE ENTERED BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND DR. JUANITA T. LACUESTA AS PATHOLOGIST AT THE TUGUEGARAO CITY PEOPLE'S GENERAL HOSPITAL (TCPGH) AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID CONTRACT OF SERVICE

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, has requested for an authority to sign for and on behalf of the Tuguegarao City Government for the renewal of the Contract of Service of Dr. Juanita T. Lacuesta as Pathologist at the Tuguegarao City General Hospital (TCPGH);

WHEREAS, Dr. Juanita T. Lacuesta is a duly licensed Pathologist, well trained practitioner and with sufficient experience and skills in Pathology who is willing to extend her services as Pathologist to TCPGH;

WHEREAS, there is a basic need for a Pathologist as a basic requirement for the continuous licensing of the clinical laboratory of the TCPGH;

WHEREAS, the Contract of Service shall commence on July 1, 2025 to June 30, 2027;

WHEREAS, the Ninth City Council during its 138th Regular Session held on May 27, 2025 approved the said Contract of Service.

NOW, THEREFORE, RESOLVE as it is hereby **RESOLVED**, to approve the Contract of Service to be entered into by and between the Tuguegarao City Government and Dr. Juanita T. Lacuesta as Pathologist at the Tuguegarao City People's General Hospital (TCPGH) and to grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said Contract of Service.
