SUBJECT:

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the letter of the City Treasurer, Mr. Buenaventura F. Lagundi, recommending the increase of charges for cemetery lots as prescribed under Section 5.C.01 of City Ordinance No. 07-2011, in view of the decision of the Department of Human Settlements and Urban Development lifting the suspension order against the City People's Memorial Park.

FINDINGS:

1. Hon. Maila Rosario S. Ting-Que indorsed to the Ninth City Council the letter of the City Treasurer, Mr. Buenaventura F. Lagundi, recommending the increase of charges for cemetery lots as prescribed under Section 5.C.01 of City Ordinance No. 07-2011, in view of the decision of the Department of Human Settlements and Urban Development lifting the suspension order against the City People's Memorial Park.
2. The City Treasurer, Mr. Buenaventura F. Lagundi informed the Committees that the Department of Human Settlements and Urban Development has lifted the suspension of license to sell and/or Cease and Desist Order against the Tuguegarao City People's

Memorial Park located at Atulayan Sur, Tuguegarao City. He further stated that considering the increase in land value overtime and additional development cost of the project, there is a need to increase the charges for cemetery lots as well as the burial fees.


3. The proposed amendments under 5.C.01 of City Ordinance No. 07-2011 are as follows:

RECOMMENDATION:


