**COMMITTEE REPORT NO. 236-2024**

**SUBJECT:**

Letter of the Punong Barangay of Annafunan West, Hon. Rico C. Baccay, on Barangay Resolution No. 09-2024 Realigning the 20% Economic Development Fund (EDF) Amounting to P1,044,324.40 from Drainage Project to Concreting of Alley Road for approval.

**FINDINGS:**

1. The fund is part of the approved 2024 Budget of Barangay Annafunan West for Drainage Project which the Barangay intends to realign to other priority projects which is the Concreting of Alley Road.
2. The realignment is sought as per advice of the City Engineering Office.
3. The City Budget Officer manifested that since the approval of the budget is by way of an ordinance, the reprogramming should also be by way of an ordinance and shall be subject to a Supplemental Budget.

4. As a Rejoinder, the City Planning and Development Officer suggested that a supplemental AIP is necessary, hence, there's a need for the Barangay Captain to convene the Barangay Development Council and pass an appropriate resolution to be approved by the Barangay Council which shall be supported by the passage of another ordinance in support to the reprogramming.

#### **RECOMMENDATIONS:**

After a thorough discussion on the subject referral, the joint Committees came up with the following suggestions;/recommendations;

- a. For the Barangay Council to convene the Barangay Development Council for the passage of an appropriate Resolution.
- b. Passage of Barangay Ordinance in support to the reprogramming.
- c. Correction of the location/ name of the project to construction of drainage at Aquino St.
- d. Submission of Supplemental Annual Investment Plan (AIP) supporting the Supplemental Budget.
- e. Submission of Program of Work.
- f. For the Barangay Captain to confer with the City Budget Office regarding their request.
