# CITY RESOLUTION NO. 243-09-2025

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN AND AMONG THE TUGUEGARAO CITY GOVERNMENT, DEPARTMENT OF MIGRANT WORKERS, DEPARTMENT OF LABOR AND EMPLOYMENT AND TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY RELATIVE TO THE PROTECTION OF MIGRANT WORKERS AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA

WHEREAS, Section 22 (c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, grants the power to the Local Chief Executive to enter into contracts on behalf of the local government unit with prior authorization by the Sangguniang Panlungsod;

WHEREAS, the Eighth City Council enacted City Ordinance No. 40-08-2022 An Ordinance Establishing the Tuguegarao City Overseas Filipino Workers (OFW) Help Desk and its Coordinating Council Defining its Powers and Functions and for Other Purposes;

WHEREAS, the Department of Migrant Workers (DMW) proposed for the execution of an interagency Memorandum of Agreement between and among the Department of Migrant Workers, Department of Labor and Employment (DOLE), Technical Education and Skills Development Authority (TESDA) and LGU of Tuguegarao City;

WHEREAS, City Ordinance No. 40-08-2022 and the abovementioned inter-agency MOA have the same purpose and contain similar provisions;

WHEREAS, upon review, the DMW strongly recommended the updating of City Ordinance No. 40-08-2022 and reiterated the need for the execution of an inter-agency MOA that will provide for better and more efficient implementation of programs and projects for Overseas Filipino Workers;



WHEREAS, after a deliberation in two (2) committee meetings held for the said purpose, the Committee on Labor and Employment found the request to be in order and beneficial to the concerned migrant workers.

**NOW**, **THEREFORE**, **RESOLVE**, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement (MOA) between and among the Tuguegarao City Government, Department of Migrant Workers (DMW), Department of Labor and Employment (DOLE and Technical Education and Skills Development Authority (TESDA) relative to the protection of migrant workers, subject to the following amendments:

- 1. In the WHEREAS clauses of the MOA, a provision should be included to reflect the existence of City Ordinance No. 40-08-2022 and that the instant MOA shall be implemented in consonance with the latter.
- 2. Amend Article II, Paragraph c.1 to read as: "Shall implement the provisions of City Ordinance No. 40-08-2022 that will help provide current information to their constituents...."
- 3. To specify who shall lead the creation of the Technical Working Group under Article III, Paragraph 1 of the MOA.

**RESOLVED FURTHER**, to grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said inter-agency MOA.

On joint motion, CITY RESOLUTION NO. 243-09-2025 was APPROVED.
