FINDINGS:

1. Under RA No. 10844, the Department of Information and Communication Technology (DICT) is mandated to be the primary policy planning, coordinating, implementing, and administrative entity of the Executive Branch of the government that will plan, develop, and promote the national ICT development agenda.
2. The DICT, pursuant to its mandate under RA No. 10844, E-Government objectives in particular, and national objectives in general, is currently in the process of developing applications and systems in order to harmonize and coordinate all national ICT plans and initiatives to ensure: (1) knowledge, information and resource-sharing; (2) database-building; and (3) agency networking linkages among government agencies.
3. The Tuguegarao City Government in its utmost support of the digitalization of the government, manifested its interest to computerize and automate the provision of its public services.
4. The DICT and Tuguegarao City Government decided to enter into a Memorandum of understanding in order to establish cooperation, collaboration and teamwork between/among them.
5. The DICT and Tuguegarao City Government expressed their joint commitment to institute the digitalization of government services and signifies their intention to enter into a Memorandum of Understanding to integrate their existing applications into the applications and systems being developed by DICT.
6. There is a need for the passage of a resolution granting authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOU.


RECOMMENDATIONS:
