The Committee met and deliberated on the referral:

COMMITTEE REPORT NO. 25-10-2025

SUBJECT:

“Draft Resolution Commending the Tuguegarao Component City Police Station Under the Leadership of Chief of Police Plt.Col. Darwin John B. Urani for Being Adjudged and Awarded as the Best Component City Police Station During the 124th Police Service Anniversary on August 12, 2025 at the Philippine National Police Headquarters, Camp Crame, Quezon City.”

ACTION TAKEN:

The members of the committee met to discuss the subject matter with the presence of the resource person/s.

FINDINGS:

1. In celebration of its 124th Police Service Anniversary on August 12, 2025, the Philippine National Police (PNP) Sub-Committee on Awards adjudged the Tuguegarao Component

City Police Station (TCCPS) as the Best Component City Police Station in the entire Philippines.

2. Such distinction is a result of the cumulative effort of the officials and personnel of the Tuguegarao Component City Police Station through the leaderships of its chiefs of police for the evaluation period, namely: PLTCOL Richard R. Gatan, PLTCOL Jhonalyn Q. Tecbobolan, PLTCOL Pepito A. Mendoza, and PLTCOL Darwin John B. Urani.

The said award has two criteria, Administrative and Operational, wherein TCCPS highlighted various accomplishments such as being evaluated as the most peaceful component police station in the region, provisions of special training, equipment, and two vehicle units, and having zero administrative cases, among other achievements.
4. On behalf of the TCCPS, Chief of Police PLTCOL. Darwin John B. Urani received the prestigious award from His Excellency President Ferdinand Romualdez Marcos, Jr., during the awarding ceremony of the 24th Police Service Anniversary on August 12, 2025 at PNP Transformation Oval, National Headquarters, Camp Brigadier General Rafael T. Crame, Quezon City.
5. The remarkable achievement of the TCCPS is worthy of recognition and commendation by the Tuguegarao City Government.
