**CITY RESOLUTION NO. 251-09-2024**

**RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND CAGAYAN VALLEY MEDICAL CENTER (CVMC) RELATIVE TO THE IMPLEMENTATION OF COMMUNITY-BASED DRUG REHABILITATION PROGRAM AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA**

**WHEREAS**, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code, grants the power to the Local Chief Executive to enter into contracts on behalf of the local government unit with prior authorization by the Sangguniang Panlungsod;

**WHEREAS**, the City Mayor, Hon. Maila Rosario S. Ting-Que, requested for an authority to represent, enter and sign for and on behalf of the Tuguegarao City Government the draft Memorandum of Agreement with Cagayan Valley Medical Center relative to the implementation of Community-Based Drug Rehabilitation;

**WHEREAS**, pursuant to Department Memorandum No. 2021-0512, otherwise known as the Interim Guidelines for the Certification of Community-Based Drug Rehabilitation Program, Local Government Units (LGUs), as the implementers to Community-Based Drug Rehabilitation Program (CBDRP), established and operated their local program by implementing different models depending on available resources in the community;

**WHEREAS**, the Tuguegarao City Government desires to engage the medical and clinical services of the Cagayan Valley Medical Center (CVMC) to standardize the implementation of the Community-Based Drug Rehabilitation Program (CBDRP) and assure quality services provided to Persons Who Use Drugs (PWUDs) in the community;

**WHEREAS**, the Cagayan Valley Medical Center (CVMC) has expressed its willingness to collaborate with the Tuguegarao City Government in the implementation of said program.

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement between the Tuguegarao City Government and Cagayan Valley Medical Center (CVMC) for the implementation of Community-Based Drug Rehabilitation Program and to grant authority to the City



Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.
