WHEREAS, Section 106 of the Local Government Code of 1991 provides that each local government unit shall have a comprehensive multisectoral development plan to be initiated by its development council and to be approved by its Sanggunian;

WHEREAS, the City Mayor has endorsed to the Ninth City Council City Development Council Resolution N0. 09, Series of 2025 titled "RESOLUTION ENDORSING TO THE SANGGUNIANG PANLUNGSOD THE HEREIN SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 1 CY 2025 FOR APPROPRIATE ACTION;"

WHEREAS, the Sangguniang Panlungsod through its Committee of the Whole has conducted a meeting with concerned department heads and program managers for the discussion of the said CDC Resolution;

WHEREAS, the Supplemental Annual Investment Program (SAIP) embodies various PPAs and other items of expenditure that are necessary for public service, general welfare, and public convenience, including upgrading, repair, and maintenance of public facilities and equipment, and implementation of environmental management projects;

WHEREAS, the Personal Services (PS) of the Local Government Unit of Tuguegarao City is a major component of the Supplemental Annual Investment Program (SAIP) by virtue of Executive Order No. 64, Section 04 dated August 2, 2024 which provides guidelines updating the salary of Civilian Government Personnel including the Salary Adjustments of Local Government Units;
