**CITY RESOLUTION NO. 255-09-2025**

**A RESOLUTION APPROVING AND AUTHORIZING THE RELEASE OF ADDITIONAL FUNDS AMOUNTING TO NINE HUNDRED TWENTY-FOUR THOUSAND FIVE HUNDRED EIGHTY-SEVEN PESOS AND SEVENTY-EIGHT CENTAVOS P924,587.78 BY THE DEVELOPMENT BANK OF THE PHILIPPINES FOR THE CONSTRUCTION OF THE TUGUEGARAO CITY EVACUATION CENTER**

**WHEREAS**, the City Mayor, Hon. Maila Rosario S. Ting-Que, has indorsed to the Ninth City Council the letter of the OIC of the Tuguegarao Lending Center, DBP, SM Carolyn C. Bago, relative to the release of additional funds for the construction of evacuation center;

**WHEREAS**, Ms. Julie Bangayan, representative of the Tuguegarao Lending Center of the Development Bank of the Philippines, informed the Joint Committee on Appropriations and Ways and Means and Committee on Rules, Laws and Ethics that Sixty-Five Million Two Hundred-Three Thousand Four Hundred Fifty-Nine Pesos and Twenty-Nine Centavos (P65,203,459.29) was approved by the bank for the construction of the Tuguegarao City Evacuation Center;

**WHEREAS**, the City Engineer, Engr. Wenceslao Arao Jr., also informed the joint committees that the City Government will incur an additional cost of Nine Hundred Twenty-Four Thousand Five Hundred Eighty-Seven Pesos and Seventy-Eight Centavos (P924,587.78) to energize the Tuguegarao City Evacuation Center Building;

**WHEREAS**, the inclusion of additional funds amounting to Nine Hundred Twenty-Four Thousand Five Hundred Eighty-Seven Pesos and Seventy-Eight Centavos (P924,587.78) to the previously approved amount of Sixty-Five Million Two Hundred-Three Thousand Four Hundred Fifty-Nine Pesos and Twenty-Nine Centavos (P65,203,459.29), which result in a total of Sixty-Six Million One Hundred Twenty-Eight Thousand Forty-Seven Pesos and 7/10 Centavos (P66,128,047.07), the total project cost remains within the scope of the original Program of Work as submitted by the City Engineering Office;

**WHEREAS**, the City Engineering Office has submitted a Program of Work covering the additional construction works for the Tuguegarao City Evacuation Center;


**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve and authorize the release of Nine Hundred Twenty-Four Thousand Five Hundred Eighty-Seven Pesos and Seventy-Eight Centavos (P924,587.78) as additional funds for the construction of the Tuguegarao City Evacuation Center.
