CITY RESOLUTION NO. 256-09-2025

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN AND AMONG THE TUGUEGARAO CITY GOVERNMENT, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR-R02) AND VARIOUS GOVERNMENT AGENCIES OF THE REGIONAL GOVERNMENT CENTER RELATIVE TO THE MAINTENANCE OF CLEANLINESS OF THE REGIONAL GOVERNMENT CENTER (RGC) AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARA CITY GOVERNMENT THE SAID MOA

WHEREAS, the Regional Government Center (RGC) which is strategically located at the northern part of Tuguegarao City is where the Regional Offices of all National Government Agencies (NGAs) and Commissions, including Government-Owned and Controlled Corporations (GOCCs) are situated;

WHEREAS, the RGC must be environment-friendly and maintained clean by all National Government Agencies (NGAs) and Commissions including Government-Owned and Controlled Corporations (GOCCs) situated therein;

WHEREAS, by virtue of Executive Order No. 192, (EO No. 192), the Department of Environment and Natural Resources (DENR-R02) is the primary government agency responsible for conservation, management, development and proper use of the country's environment and natural resources;

WHEREAS, the parties recognized the importance of collaboration and partnership in order to achieve the objectives of the project, and have agreed to support and work together for the clean and green revolution activity, consistent with the objectives and requirements of their respective mandates and programs;

WHEREAS, the FCF Minerals Corporation donated waste bins to DENR-R02 for distribution among National Government Agencies (NGAs) and Commissions including Government-Owned and Controlled Corporations (GOCCs) within the RGC;

WHEREAS, the twenty-nine (29) sets of three waste bins, each consisting of *Nabubulok*, *Di Nabubulok* and *Nareresiklo*, shall be installed strategically within the RGC;

WHEREAS, the Local Government Unit (LGU) of Tuguegarao City shall collect the wastes from the twnty-nine (29) waste bins on the following schedules: Biodegradable shall be collected on Mondays, Wednesdays, and Fridays. Non-Biodegradable and Recyclable shall be collected on Tuesdays, Thursdays and Sundays;

WHEREAS, Ecological Solid Waste Management Committee (ESWM Committee) shall be created which shall be composed of two (2) focal persons, one (1) from CDD-DENR Regional Office 02 and one (1) from EMB Regional Office 02;

WHEREAS, categorized list differentiating biodegradable and non-biodegradable materials shall be labeled in the trash bins to enhance people's awareness on waste segregation;

WHEREAS, there is a need for the passage of a resolution granting authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA;

WHEREAS, upon the evaluation of the subject referral, the Committee on Rules, Laws and Ethics recommended for the adoption and approval of the Memorandum of Agreement and the granting of authority to the City Mayor to sign for and on behalf of the Tuguegarao City Government the said MOA.

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to approve the Memorandum of Agreement between and among the Tuguegarao City Government, Department of Environment and Natural Resources (DENR-R02) and various government agencies of the Regional Government Center relative to the maintenance of cleanliness of the Regional Government Center (RGC) and to grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.

On motion of Hon. Baccay, duly seconded by Hon. Arago and without any objection, CITY RESOLUTION NO. 256-09-2025 was APPROVED.
