SUBJECT:

Indorsement of the City Administrator, Mr. Juanito A. Calubaquib, on the request of Nissan Royce Motor Center, Inc. for a document authorizing the Tuguegarao City Government to receive the refund of Safeguard Tax in relation to the purchase NP300 Navarra 2.5 VL MT 4x4 which was delivered on August 04, 2021.

FINDINGS:


1. City Administrator, Mr. Juanito A. Calubaquib indorsed to the Ninth City Council the request of Nissan Royce Motor Center, Inc. for a document authorizing the Tuguegarao City Government to receive the refund of Safeguard Tax in relation to the purchase NP300 Navarra 2.5 VL MT 4x4 which was delivered on August 04, 2021.
2. One of the requirements for the City Government to be able to refund the Safeguard Tax amounting to One Hundred Twenty-Three Thousand Two Hundred Pesos (P123,200.00) that was paid at the time that NP300 Navarra 2.5 VL MT 4x4 was purchased is Secretary Certificate; however, such requirement is not applicable because the City Government is not a corporation.

3. Instead of a Secretary's Certificate, the committee agrees that a resolution be passed authorizing the City Treasurer, Mr. Buenaventura F. Lagundi to collect the refund of Safeguard Tax from Royce Motor Center, Inc.


RECOMMENDATION:
