CITY RESOLUTION NO. 257-09-2025

RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO OPEN A BANK ACCOUNT AT THE LAND BANK OF THE PHILIPPINES (LBP) UNDER THE NAME OF TUGUEGARAO CITY GOVERNMENT PURPOSELY FOR THE IMPLEMENTATION OF THE MEMORANDUM OF AGREEMENT ON LINK.BIZPORTAL PURSUANT TO CITY RESOLUTION NO. 594-09-2024

WHEREAS, the Ninth City Council in its 113th Regular Session held on October 29, 2024 approved City Resolution No. 594-09-2024 *Approving the Payroll Servicing Agreement Between the Tuguegarao City Government and the Landbank of the Philippines (LBP) Relative to the LandBank Link.BizPortal and Granting Authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to Sign for and on Behalf of the Tuguegarao City Government the said MOA;*

WHEREAS, the City Treasurer, Mr. Buenaventura F. Lagundi, in his letter dated May 27, 2025 requested for the opening of a separate Land Bank of the Philippines account purposely for the implementation of the Memorandum of Agreement on Link.BizPortal which was authorized by the Sangguniang Panlungsod by virtue of the above City Resolution No. 594-09-2024;

WHEREAS, the Link.BizPortal is the system of the Landbank of the Philippines for the adoption of general collections;

WHEREAS, the Tuguegarao City Government does not have a depository account for general fund in the Landbank of the Philippines;

WHEREAS, after a careful deliberation on the matter, the Joint Committee on Rules, Laws and Ethics and Committee on Appropriations and Ways and Means found the same to be meritorious and in order, and favorably recommended for the approval on the request of the City Treasurer, Mr. Buenaventura



F. Lagundi, for the opening of a separate Landbank of the Philippines account purposely for the implementation of the Memorandum of Agreement on Link.BizPortal.


On joint motion, **CITY RESOLUTION NO. 257-09-2025** was **APPROVED**.
