## CITY RESOLUTION NO. 261-09-2024

## RESOLUTION APPROVING THE REQUEST OF MS. ELIZABETH G. DUPAYA TO HOLD SPECIAL DERBIES ON JULY 1, 3, 8, 10, 15, 17, 22, 24, 29 AND 31, 2024 ONLY

WHEREAS, Hon. Maila Rosario S. Ting-Que indorsed to the Ninth City Council the request of the Dupaya Recreation Center to hold special derbies on various dates of July 2024;

WHEREAS, Section 10(D) of City Ordinance No. 32-08-2019 states that the City Mayor may issue permits for special cockfights, cock or stag derbies including cockfights via satellite participated in by cockers and breeders through invitations upon application duly approved by the Sangguniang Panlungsod through resolution of 30-working days before the scheduled playdate;

WHEREAS, the Committee on Games, Entertainment and Amusement informed the Dupaya Manager about City Resolution No. 248-09-2024 titled "Resolution Urging the City Mayor, Hon. Maila Rosario S. Ting-Que, to Implement the Pertinent Provisions of City Ordinances, City Resolutions and Committee Report No. 033-2024 Pertaining to the Operation of Dupaya Recreation Center, Inc. and the Reported Use of Betting Machine in its Operations;"

WHEREAS, the Dupaya Recreation Center, Inc. should adhere to traditional betting during its Special Derbies;
