b. CDC Resolution No. 05-2024 titled "City Development Council Resolution Adopting and Endorsing to the August Sangguniang Panlungsod the herein attached Supplemental Local Development Investment Program (SLDIP) No. VI CY 2023-2028 for appropriate action

c. CDC Resolution No. 06-2024 titled "City Development Council Resolution Adopting the Annual Investment Program (AIP) CY 2025 and Endorsing the same to the August Sangguniang Panlungsod for appropriate action

FOR THE PRESIDING OFFICER:

The Committee of the Whole together with the presence of the members of the Local Finance Committee and concerned department heads/representatives/program managers, met and deliberated in a series of meetings last October 4, 2024, October 7, 2024, October 9, 2024 and October 21, 2024, respectively, on the Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the following City Development Council Resolutions, to wit:

- 1. CDC Resolution No. 04-2024 titled "City Development Council Resolution Adopting and Endorsing to the August Sangguniang Panlungsod the Herein Attached CY 2025 Local Disaster Risk Reduction and Management Fund Investment Program (LDRRMFIP) of Tuguegarao City;
- 2. CDC Resolution No. 05-2024 titled "City Development Council Resolution Adopting and Endorsing to the August Sangguniang Panlungsod the Herein Attached Supplemental Local Development Investment Program (SLDIP) No. VI CY 2023-2028 for Appropriate Action;
- 3. CDC Resolution No. 06-2024 titled "City Development Council Resolution Adopting the Annual Investment Program (AIP) CY 2025 and Endorsing the Same to the August Sangguniang Panlungsod for Appropriate Action

ACTIONS TAKEN:

Hon. Bienvenido C. De Guzman II, Chairman of the Committee of the Whole has commissioned Hon. Jude Bayona, in his capacity as the Chairman of the Committee on Appropriations and Ways and Means, to facilitate the deliberation of the above-subject CDC Resolutions.

FINDINGS:

1. On CDC Resolution No. 04-2024:

The members of the committee scrutinized the various priority Programs, Projects and Activities (PPAs) under the Local Disaster Risk Reduction and Management Fund Investment Program (LDRRMIFP) for Calendar Year 2025 as presented by Dr. Roderick B. Ramirez, CDRRMO Head.

The Five Percent (5%) Local Disaster Risk Reduction and Management Fund amounting to Seventy Five Million Seven Hundred Seventy One Thousand Four Hundred Forty Nine Pesos (P75,771,449.00) will be utilized for the for the PPAs necessary for quick response program, disaster mitigation and prevention, preparedness, response, rehabilitation and recovery for the benefit of all stakeholders and constituents.

The LDRRMFIP for CY 2025 is consistent with NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 which outlines the policies and guidelines on the allocation and utilization of Local Disaster Risk Reduction and Management Fund (LDRRMF) and COA Circular # 2012-002 dated September 12, 2012.

The following were the suggestions/recommendations made by some members:

- For the proposed e-911 to cater not only the city but province wide.
- To consider additional funding for assistance to volunteers (emergency responders) and livelihood assistance to vulnerable groups, families and individuals in the ensuing supplemental budget.
- To put up CDRRMO Sub-Office in a strategic area.
- To consider the construction of an evacuation center.

2. On CDC Resolution No. 05-2024:

Ms. Chona Sedano, CPDO, presented the various Programs, Projects and Activities (PPAs) under the Supplemental Local Development Investment Program (SLDIP) No. VI CY 2023-2028 with the corresponding funding requirements. She mentioned, among others, that there are increases in the budgetary amounts of some programs and projects in the approved LDIP 2023-2028 and then enumerated the following new PPAs not included in the approved LDIP 2023-2028 that need funding for its implementation:

- a. Migrant Workers and Family Development Program -Php 300,000.00
- b. Mental Health Program Php100,000.00
- c. Parks and Green Spaces Development- Php200,000.00
- d. Wildlife Resources Conservation and Protection Php200,000.00
- e. PPAs under the 20% Development Fund

There is a need to integrate the various priority programs, projects and activities and other items of expenditures in the LDIP as supplements thereof for efficiency and effectiveness of services and needed facilities of the Local Government Unit of Tuguegarao City.

The following were the suggestions/recommendations by some members in the following PPAs:

Bahayanihan Program:

- To specify the number of housing units to be constructed.
- To provide the committee with photos of the housing unit.
- Donations/pledges in cash to be deposited as Trust Fund purposely for the said program.
- To include beneficiaries and would-be beneficiaries to undergo capacity building.
- To provide adequate food assistance for laborers.

Mental Health Program:

- To consider for additional funding in the ensuing supplemental budget.

Concreting of Roads:

- To submit inventory of roads and pertinent documents i.e. Deed of Donation to support ownership by the barangay/city by the CPDO.

Drainage Structures:

- To redesign drainage structures by putting a strainer therein.

Wildlife Resources Conservation and Protection:

- To submit list of wildlife in the city.

The following were the modifications to some PPAs under the SLDIP:

- -"Women's Month Celebration" instead of "Women's Day Celebration."
- "GAD Office" instead of "GAD corner."
- -"Attended" instead of "Conducted" under SPES.

3. On CDC Resolution No. 06-2024

. . .

The members of the committee scrutinized the various priority Programs, Projects and Activities (PPAs) by sector as contained in the CY 2025 Annual Investment Program (AIP) as presented by Ms. Sedano.

The AIP constitutes the total resource requirements of all programs, projects and activities consisting of the annual capital expenditure and regular operating requirements of the Tuguegarao City Government.

The CY 2025 AIP includes the Personal Services, Maintenance and Other Operating Expenses, Financial Expenses, Capital Outlay, 20% Development Fund, 5% DRRM Fund and other special purpose funds.

The following were the observations/recommendations made by some members:

To submit a detailed/specific program of work. The rectified/modified Programs of Work were subsequently submitted reflecting the observations/recommendations of some members.

- Program of Work variation/ alteration is subject to the council's approval.
- To consider additional funding for the "Buntis Congress" under the City Nutrition Program in the ensuing supplemental budget.

The following were submitted upon the requests of some members:

- 1.) Engr. Palacay, Asst. City Engineer, submitted the following plans and drawings: Subdivision Plan & Cadastral map of Sitio Bayawa at Larion Alto, Upgrading of Tuguegarao City People's General Hospital, Improvement of Tuguegarao City People's Gymnasium and Construction of City Library.
- 2.) Ms. Sedano, CPDO, submitted a certification that majority of the projects funded under the AIP for CY 2025, 20% Development Fund, are included in the Official List of Inventory of Roads and certifying further that should there be identified projects which are not in the said Official List, the same shall not be implemented pending the submission of a copy of the Deed of Donation to ensure that all public investments are spent on public facilities and utilities and/or properties.

RECOMMENDATIONS:

After thorough discussions on the subject CDC Resolution No. 04-2024, CDC Resolution No. 05-2024 and CDC Resolution No. 06-2024 and finding the same to be in order, meritorious and beneficial to the constituents of the city, the Committee of the Whole favorably recommended the passage of appropriate Sangguniang Panlungsod Resolutions adopting and approving the following:

As indicated in the said plan, from the mandatory 5% of the 2025 Annual Budget, the Local Disaster Risk Reduction and Management Fund has an amount of (P75,771,014.00) which will be utilized for the PPAs necessary for quick response program, disaster mitigation and prevention, preparedness, response, rehabilitation and recovery for the benefit of all stakeholders and constituents. The fund shall be distributed as follows:

1.	Quick Response Fund-	P 22,731,435.00
2.	Disaster Prevention and Mitigation-	P 6,300,000.00
3.	Disaster Preparedness-	P 26,440,014.00
4.	Disaster Response-	P 10,800,000.00
5.	Disaster Rehabilitation and Recovery	P 9,500,000.00
