The Committee met and deliberated on the referral:

SUBJECT:

"Indorsement of the City Administrator, Mr. Juanito A. Calubaquib, on the letter and route plan from Dr. Esther N. Perez-Mari, University of Cagayan Valley President, relative to the temporary road closure of Bonficacio St., to give way for the UCV Foot Parade on September 27, 2025."

ACTION TAKEN:

The members of the committee met to discuss the subject matter with the presence of the resource persons.

FINDINGS:

- 1.) On August 22, 2025, the Office of City Administrator Juanito Calubaquib indorsed the request of the University of Cagayan Valley for the temporary closure of Bonifacio Street for the conduct of their foot parade on September 27, 2025.
- 2.) Around 19,000 participants will be attending the event. Kalesas and seven floats will also be joining the parade which is expected to last around three hours.
- 3.) Considering the observations of the TMG on the foot parade during the previous year, the whole stretch of Balzain Highway will also be temporarily closed.
- 4.) There is a need to declare the temporary closure of Bonifacio Street from corner Lecaros Street to Corner College Avenue to pave way for the foot parade, and to ensure the safety of participants and the public.
- 5.) The PSSO/TMG has devised a traffic rerouting plan for the said foot parade activity.

RECOMMENDATION:

Finding the request to be in order and with merit, the committee favorably recommends for the passage of an Ordinance Declaring the Temporary Road Closure of Bonifacio Street from corner Lecaros Street to Corner College Avenue, and Balzain Highway to Pave Way for the conduct of the Foot Parade of the University of Cagayan Valley, on September 27, 2025 from 7:00 AM to 10:00 AM.

The committee further recommends the following:

- 1.) For PSSO/TMG to install early warning signages, and implement its rerouting plan.
- 2.) Early dissemination through the Tuguegarao City Information Office, University of Cagayan Valley Page, and other media outlets.

CITY ORDINANCE DECLARING THE TEMPORARY CLOSURE OF BONIFACIO STREET FROM CORNER LECAROS STREET TO CORNER COLLEGE AVENUE, AND BALZAIN HIGHWAY FOR THE CONDUCT OF THE FOOT PARADE OF THE UNIVERSITY OF CAGAYAN VALLEY ON SEPTEMBER 27, 2025 FROM 7:00 AM TO 10:00 AM

WHEREAS, pursuant to the pertinent provisions of Section 21 of Republic Act 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Tuguegarao is authorized to temporarily close some of the local roads falling within its jurisdiction;

WHEREAS, the University of Cagayan Valley requested the City Mayor, Hon. Maila Rosario S. Ting-Que, for a temporary closure of Bonifacio Street in view of the conduct of a foot parade in celebration of their 77th Founding Anniversary on September 27, 2025;

WHEREAS, around 19,000 participants will be attending the parade which is expected to last around three hours;

WHEREAS, the Tuguegarao City Traffic Management Group (TMG)/Public Safety and Security Office has devised a traffic and rerouting Plan aims to establish smooth flow of traffic during the activity, provide safety, security, and control measure, and provide alternate routes;

WHEREAS, considering the observations of the TMG on the foot parade during the previous year, the whole stretch of Balzain Highway will also be temporarily closed;

WHEREAS, the Ninth City Council in its 11th Regular Session held on September 12, 2025, taking in mind public safety and security, found the request to be in order, with merit and beneficial to the constituents of Tuguegarao City, hence recommended for its approval.

NOW, THEREFORE, be it **ORDAINED**, by the Tenth City Council in session assembled to enact the following ordinance:

SECTION 1. TITLE. This Ordinance shall be known as "CITY ORDINANCE DECLARING THE TEMPORARY CLOSURE OF BONIFACIO STREET FROM CORNER LECAROS STREET TO CORNER COLLEGE AVENUE, AND BALZAIN HIGHWAY FOR THE CONDUCT OF THE FOOT PARADE OF THE UNIVERSITY OF CAGAYAN VALLEY ON SEPTEMBER 27, 2025"

SECTION 2. SCOPE AND LIMITATION. This Ordinance shall cover the whole stretch of Bonifacio Street from corner Lecaros Street to corner College Avenue, and Balzain Highway as temporary closed from vehicular traffic to pave way for the conduct of a foot parade in celebration of the 77th Founding Anniversary of the University of Cagayan Valley on September 27, 2025 from 7:00 AM to 10:00 AM.

SECTION 3. INFORMATION. This Ordinance shall be disseminated through signages and all mass media outlets in Tuguegarao City including the Facebook Page of Tuguegarao City Information Office and University of Cagayan Valley.

SECTION 4. IMPLEMENTATION. This Ordinance shall be implemented by the Office of the City Mayor through the Public Safety and Security Office (PSSO)/Traffic Management Group (TMG) in coordination with the Office of the City Chief of Police, City General Services Office and City Information Office.

SECTION 5. EFFECTIVITY. This Ordinance shall take effect on September 27, 2025 from 7:00 AM to 10:00 AM.
