The committee met and deliberated on the referral:

SUBJECT:

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the request of the Manager of Dupaya Recreation Center, Inc., Ms. Elizabeth G. Dupaya, for special permit to hold cockfight/hack fight and derby schedule particularly and exclusively every Friday of each month.

FINDINGS:


1. The City Mayor, Hon. Maila Rosario S. Ting-Que, indorsed to the Ninth City Council the request of the Manager of Dupaya Recreation Center, Inc., Ms. Elizabeth G. Dupaya, for special permit to hold cockfight/hack fight and derby schedule particularly and exclusively every Friday of each month.
2. Section 10, Paragraph D of City Ordinance No. 32-08-2019 states that the City Mayor may issue permits for special cockfights, cock or stag derbies including cockfights via satellite participated in by cockers and breeders through invitations upon application duly approved by the Sangguniang Panlungsod through a resolution **30-working days** before the scheduled playdate.
3. The Committee decided to deny the herein request for the reason that the word ***“to hold cockfight/hack fight and derby schedule particularly and exclusively every Friday of each month”*** stated in their letter violates the above City Ordinance granting legislative franchise.

4. The requestor should also indicate special occasions on their request as a basis for the conduct of Special Derbies and to adhere on P.D. 499 for applying excessive conduct of Hack fights.

RECOMMENDATION:

After a thorough discussion, the committee recommends to deny the herein request subject to final approval in the plenary.
