

RESOLVED FURTHER, that a copy of this Resolution be forwarded to Ms. Jhasmine Smyll Poblete for her information.


On motion of Hon. Quilang and without any objection, **CITY RESOLUTION NO. 280-09-2024** was **APPROVED** under suspended rules.
