CITY RESOLUTION NO. 283-09-2025

RESOLUTION APPROVING THE MEMORANDUM OF UNDERSTANDING BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND DEPARTMENT OF HEALTH-CAGAYAN VALLEY CENTER FOR HEALTH DEVELOPMENT (DOH-CVCHD) AND AUTHORIZING THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA

WHEREAS, Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, grants the Local Chief Executive the power to enter into contracts for and on behalf of the local government unit upon prior authorization by the Sangguniang Panlungsod;

WHEREAS, the Acting City Mayor, Hon. Bienvenido C. De Guzman II, requested for an authority to represent, enter and sign for and on behalf of the Tuguegarao City Government the draft Memorandum of Understanding between the Tuguegarao City Government and Cagayan Valley Center for Health Development (CVCHD);

WHEREAS, the Epidemiology Bureau (EB) currently utilizes four (4) major information systems to collect surveillance information from the Disease Reporting Units (RDUs) and Epidemiology and Surveillance Units (ESUs);

WHEREAS, in addition to the major information systems, the Regional Epidemiology and Surveillance Unit (RESU) uses Vigiflow web-based system for AEFI, Regional COVID CODA and other information systems for reporting;

WHEREAS, with the current work arrangements and the nature of work done by DRUs/ESUs, the use of laptop computers offers a better alternative with desktop computers, with advantages in portability, flexibility and convenience;

WHEREAS, the Department of Health (DOH) through the Epidemiology Bureau sub-allotted and transferred funds drawn from the MOOE of the Epidemiology Bureau, FY 2024 General Appropriations Act, to the Centers of Health Development (CHDs) for the procurement of the ICT equipment;

WHEREAS, the DOH-CVCHD shall allocate/deploy a laptop computer unit to the Tuguegarao City Government for the DOH Surveillance Information System (HSIS) and for surveillance report generation;

WHEREAS, the Ninth City Council after a thorough deliberation on the subject matter, suggested the following:

- 1. To amend the title from Memorandum of Understanding to Memorandum of Agreement
- 2. To reflect the timeline
- 3. To define unserviceable
- 4. To include the specifications of the laptop computer

WHEREAS, the Ninth City Council during its 142nd Regular Session held on June 24, 2025 found the request to be in order and beneficial and deemed it proper and necessary to approve the herein resolution.


