**SUBJECT:**

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the draft Deed of Donation between the Tuguegarao City Government and Philippine Charity Sweepstakes Office (PCSO) regarding the donation of Medical Transport Vehicle.

**FOR THE PRESIDING OFFICER:**

The Committee on Rules, Laws and Ethics and Committee on Health and Sanitation met and deliberated on the Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the draft Deed of Donation between the Tuguegarao City Government and Philippine Charity Sweepstakes Office (PCSO) regarding the donation of Medical Transport Vehicle. The Joint Committees respectfully submit the herein Committee Report and has the honor to report to this August body in session the following actions taken, its findings and recommendations.

**ACTIONS TAKEN:**

1. The joint committees conducted a thorough and wholistic evaluation of the subject matter on December 12, 2024.

2. Resource persons were present to assist the joint committees in the committee deliberation.

#### **FINDINGS:**

1. The Philippine Charity Sweepstakes Office (PCSO) is the principal government agency tasked to raise and provide funds for health programs, medical assistance and services, and charities of national character.
2. The PCSO, through the Medical Transport Vehicle Donation Program (MTVDP), aims to donate medical transport vehicles to Local Government Units (LGUs) which are essential for ensuring that patients can reach healthcare facilities in a timely and safe manner.
3. The PTV shall be used exclusively for transport of patients whose condition is of a non-life-threatening nature, affording them safe and comfortable conveyance, for medical outreach programs and as a service extension of the Tuguegarao City Government.
4. Pursuant to its mandate, the PCSO, upon approval by the Office of the President, procured Patient Transport Vehicles (PTVs) for distribution to qualified beneficiaries.
5. To complete the Donation, there is a need to request authority from the Sangguniang Panlungsod to allow the City Mayor to enter into and sign for and on behalf of the Tuguegarao City Government the Deed of Donation with Philippine Charity Sweepstakes Office regarding the donation of Medical Transport Vehicle.


#### **RECOMMENDATIONS:**




