#### SUBJECT:

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the draft Memorandum of Agreement between the Tuguegarao City Government and University of Saint Louis Tuguegarao relative to the work immersion of its Senior High Students

## FINDINGS:

- 1. Hon. Maila Rosario S. Ting-Que indorsed to the Ninth City Council, requesting for an authority to represent, enter and sign for and on behalf of the Tuguegarao City Government the draft Memorandum of Agreement with University of Saint Louis Tuguegarao relative to the Work Immersion of its Senior High Students.
- 2. University of Saint Louis Tuguegarao envisions an integral human formation of the youth who will become mature Christians and active members of the Church.

- 2. There are Thirty-two (32) Grade 12 Science Technology Engineering and Mathematics Health (STEM H) students.
- 4. There will be five (5) nursing students and three (3) medical technologist students per batch who will undergo 80-hour Work Immersion and be deployed at the Tuguegarao City People's General Hospital.
- 5. The Work Immersion of the students will start after the approval of the herein Memorandum of Agreement (MOA) by the Ninth City Council.

## **RECOMMENDATION:**

Finding the terms and conditions of the Memorandum of Agreement to be in order and beneficial to the constituents of Tuguegarao City particularly the students concerned, the committee recommends the approval of Memorandum of Agreement between the Tuguegarao City Government and University of Saint Louis Tuguegarao relative to the Work Immersion of its Senior High Students and authorize the City Mayor, Hon. WHEREAS, the University of Saint Louis Tuguegarao has requested the Tuguegarao City Government for the work immersion of its Senior High School (SHS) students as part of their curriculum;

WHEREAS, it is necessary for University of Saint Louis Tuguegarao to enter into a Memorandum of Agreement (MOA) with the Tuguegarao City Government to make the MOA legally binding;

**WHEREAS**, the City Mayor, Hon. Maila Rosario S. Ting-Que, requested the Ninth City Council to grant her an authority to sign for and on behalf of the Tuguegarao City Government the said MOA;

WHEREAS, after a deliberation in a committee meeting held for the said purpose, the Committee on Education found the request to be in order and beneficial to the concerned students;

WHEREAS, after the approval of the concomitant committee report, the Ninth City Council during their 119<sup>th</sup> Regular Session held on December 17, 2024 deemed it proper and necessary to approve the herein resolution.

WHEREAS, USL has requested for a work immersion training of # Grade 12 Science Technology Engineering and Mathematics Health (STEM H) students;



WHEREAS, the first party requires at least 80 hours of training for the students at the SECOND PARTY'S office/school;

NOW THEREFORE, for and in consideration of the concerns and purposes of both parties, they voluntarily agree and stipulate the following terms and conditions:

## Responsibilities of the FIRST PARTY:

That the FIRST PARTY shall:

- identify and indicate the SHS track/s, strands, and/ or specialization/s which will be the subject of the partnership.
- designate a person in charge of coordinating with the second party and supervising the activities of the students for the duration of the work immersion program.
- monitor each student's progress throughout the entire work immersion program so as to make sure that the tasks assigned to each student are meaningful, challenging, and applicable to his/her particular programs, and are able to maximize the quality of the learning experience.
- 4. provide the second party an evaluation tool for the students' immersion performance.
- issue a grade to the student upon completion of the requirements based on existing policy within prescribed period.
- provide the SECOND PARTY a Certificate of Appreciation in the SHS immersion program in acknowledgment to their support and active participation.
- 7. ensure that on-boarding session before the deployment is conducted.

#### II. Responsibilities of the SECOND PARTY

#### That the SECOND PARTY shall:

- 1. conduct an orientation on the company's rules, policies and guidelines regarding immersion.
- 2. assign a supervisor to guide and assist the student.
- provide the student with relevant and meaningful activities that will further enhance his/her knowledge and skills on his/her field of specialization.
- 4. notify the school, through the immersion adviser, of any problem regarding the student-trainee.
- notify the school, through the immersion teacher, of any move to terminate, due to reasonable cause, the training of any student.
- 6. ensure that all provisions of this MOA are duly implemented.
- 7. provide safe working condition/environment for the student.
- 8. assist trainee in solving problems or issues that may arise in the course of the OJT Program;
- adhere to all laws, memorandums, and circulars, especially those about child protection as provided for in the guidelines for immersion.
- notify the school through the Immersion Area Coordinator and/or Immersion Teacher for any field work that may be required of the student and hence require the student a separate Parental Consent for this purpose.
