Pursuant to Section 316(f) of the Local Government Code of 1991, the initial review of the Local Finance Committee on the **Sangguniang Kabataan Supplemental Budget No. 1-2024 of Barangay Linao East** in the amount of **One Million Five Hundred Sixty Five Thousand Pesos (P 1,565,000.00)** approved through **SK Resolution No. 5-2024** on April 7, 2024 shows substantial compliance with the provisions of the Code and its implementing rules and regulations.
