COMMITTEE REPORT NO. 295 - 2024

SUBJECT:

"Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the request of Barangay Capatan for rerouting of traffic in the Celebration of its Barangay Patronal Fiesta"

ACTION TAKEN:

The members of the committee met to discuss the subject matter with the presence of the resource person/s.

FINDINGS:

1. The Sangguniang Barangay of Capatan, Tuguegarao City, passed Resolution No. 24, Series of 2024, entitled "RESOLUTION OF THE BARANGAY COUNCIL APPROVING THE TEMPORARY REROUTING OF TRAFFIC ALONG MOLAVE STREET AS THE ENTRANCE AND NARRA STREET AS THE EXIT LEADING TO CAPATAN INTEGRATED SCHOOL, IN OBSERVANCE OF THE BARANGAY CAPATAN PATRONAL FEAST ON DECEMBER 26-27, 2024."

- 2. Under Barangay Resolution No. 24-2024, the rerouting plan will cover Molave Street, starting at the Petron Gasoline Station as the entrance point, and Narra Street, heading toward Capatan Integrated School, as the exit point.
- 3. City Mayor Maila Rosario S. Ting-Que indorsed to the 9th City Council the letter dated November 21, 2024 of Punong Barangay Jayson Allam, requesting the enforcement of the rerouting plan for the subject streets.
- 4. The implementation of the rerouting plan is necessary to ensure the smooth flow of vehicles and pedestrians during the barangay patronal feast.
- 5. The rerouting of traffic will help ensure the safety and convenience of visitors and travelers.
- 6. Pursuant to Section 16 of the Local Government Code, there is a need for the City to enact an ordinance to efficiently enforce the requested rerouting plan.

RECOMMENDATION:

After a thorough discussion on the subject matter, the Committee favorably recommends for the passage of an Ordinance Rerouting the Flow of Traffic from Molave Street to Narra Street, Barangay Capatan, Tuguegarao City for the Celebration of their Patronal Fiesta, with the following recommendations:

- 1. Deployment of traffic enforcers from the TMG to assist the Barangay officials and tanods in enforcing the rerouted the traffic flow and to maintain peace and order;
- 2. Visibility of police officers from the Tuguegarao Component City Police Station COMPAC;
- 3. Placement of traffic signs/traffic advisory at the entry points, exit points, and other appropriate spaces along the covered streets; and
- 4. Information dissemination through the Tuguegarao City Information Office and other media outfits;

CITY ORDINANCE NO.

ORDINANCE REROUTING THE FLOW OF TRAFFIC FROM MOLAVE STREET TO NARRA STREET, BARANGAY CAPATAN, TUGUEGARAO CITY ON DECEMBER 26-27, 2024 FOR THE CELEBRATION OF THEIR PATRONAL FIESTA

WHEREAS, Section 16 of the Local Government Code of 1991 provides that "Every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, the Sangguniang Barangay of Capatan, Tuguegarao City, passed Resolution No. 24, Series of 2024, entitled "RESOLUTION OF THE BARANGAY COUNCIL APPROVING THE TEMPORARY REROUTING OF TRAFFIC ALONG MOLAVE STREET AS THE ENTRANCE AND NARRA STREET AS THE EXIT LEADING TO CAPATAN INTEGRATED SCHOOL, IN OBSERVANCE OF THE BARANGAY CAPATAN PATRONAL FEAST ON DECEMBER 26-27, 2024";

WHEREAS, Barangay Resolution No. 24-2024 of Barangay Caggay provides that the rerouting plan will cover Molave Street, starting at the Petron Gasoline Station as the entrance point, and Narra Street, heading toward Capatan Integrated School, as the exit point;

WHEREAS, City Mayor Maila Rosario S. Ting-Que indorsed to the Ninth City Council the letter dated November 21, 2024 of Punong Barangay Jayson Allam, requesting the enforcement of the rerouting plan for the subject streets.

WHEREAS, the implementation of the rerouting plan is necessary to ensure the smooth flow of vehicles and pedestrians during the barangay patronal feast.

WHEREAS, the rerouting of traffic will help ensure the safety and convenience of visitors and travelers, as well as minimize traffic congestion within the barangay during the celebration.

WHEREAS, the Ninth City Council during its 119th Regular Session held on December 17, 2024 deemed it necessary to approve the herein request.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, by the Ninth City Council, in session assembled, to enact:

SECTION 1. TITLE. This ordinance shall be known as "An Ordinance Rerouting the Flow of Traffic from Molave Street to Narra Street, Barangay Capatan, Tuguegarao City on December 26-27, 2024 for the Celebration of Their Patronal Fiesta."

SECTION 2. REROUTING. The following streets shall be subject to rerouting on December 26, 2024 to December 27, 2024, and shall be implemented to their fullest extent to ensure an orderly and peaceful observance of the patronal fiesta of Barangay Capatan:

ONE-WAY TRAFFIC FLOW

-From Molave Street as Entrance Point

-Narra Street going to Capatan Integrated School as Exit Point

SECTION 3. IMPLEMENTATION. The Office of the City Mayor through the Public Order and Safety Office (POSO)/Traffic Management Group (TMG) shall implement the provisions of this ordinance in coordination with the, Tuguegarao Component City Police Station, Civil Society Organizations and Barangay Capatan officials.

SECTION 4. INFORMATION DISSEMINATION. The Tuguegarao City Information Office shall cause the widest dissemination of this Ordinance upon its approval. Signages shall be also immediately installed at the area.

SECTION 5. SEPARABILITY CLAUSE. If any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall remain in full force and effect.

SECTION 6. REPEALING CLAUSE. City Ordinances and administrative regulations or part/s thereof which are inconsistent with any provisions of this ordinance are hereby repealed, amended or modified accordingly.

SECTION 7. EFFECTIVITY. This ordinance shall take effect upon its approval.
