1. The Commission on Human Rights Central Office is conducting an Annual Awarding to all Regional Offices of the Commission on Human Rights.


2. The said awarding was organized by the Commission on Human Rights Central Office Strategic Communication Division (SCD) which was held last December 20, 2023.


