**ACTIONS TAKEN:**


1. The committee conducted a thorough and wholistic evaluation of the subject matter on January 31, 2024
2. Resource persons were present to assist the committee in the committee deliberation.

**FINDINGS AND RECOMMENDATIONS:**

Pursuant to Section 458 (1)(i) of RA 7160 otherwise known as the Local Government Code of 1991, only Barangay Ordinances shall be passed by the City Council for review and approval and not Barangay Resolutions, therefore, Resolution No. 06, series of 2024 titled "*A Resolution Creating the Official Seal of Sangguniang Barangay of Leonarda*" and Resolution No. 001-2023, Series of 2023 titled "*A Resolution Adopting the Internal Rules of Procedure of the Sangguniang Barangay of Leonarda, Tuguegarao City Cagayan*" of *Barangay Leonarda.*" are outside the scope of review of the City Council.

After a thorough discussion on the subject matter, the committee hereby recommends that Barangay Leonarda shall come up with an Ordinance Creating their Official Seal instead of a Resolution.
