**COMMITTEE REPORT NO. 42-10-2025**

**SUBJECT:**

Indorsement of the City Administrator, Mr. Juanito A. Calubaquib, on the request of Punong Barangay Virginia A. Tumaliuan of Atulayan Sur and Legal Comment No. 26-2025 of the City Legal Officer, Atty. Roderick S. Iquin, relative to the conduct of an amusement activity or "perya" in celebration of the patronal feast of Atulayan Sur for information and appropriate action.

**FINDINGS:**

1. City Administrator, Mr. Juanito A. Calubaquib indorsed to the Tenth City Council on the request of Barangay Atulayan Sur relative to the conduct of amusement activity or perya to raise funds for their Annual Feast Celebration.
2. The Punong Barangay of Atulayan Sur, Hon. Virginia A. Tumaliuan, mentioned the plan to establish a Local Carnival (Perya) at Zone 6, Cabalza Street, Atulayan Sur, Tuguegarao City, which will commence upon approval of the request and run until October 30, 2025 from 7:00 P.M. to 10:00 P.M. on Sundays to Thursdays, and from 7:00 P.M. to 11:00 P.M. on Fridays and Saturdays to further enliven the Barangay Patronal Fiesta celebration.

3. The request to conduct peryahan will form part of their fund-raising activity in celebration of their annual Patronal Fiesta.
4. Attached to their request letter, Barangay Atulayan Sur already submitted the Resolution to conduct an amusement activity or perya to raise funds for Annual Feast Celebration of the Barangay, A Resolution Granting Authority to the Barangay Government through Punong Barangay Honorable Virginia A. Tumaliuan, as it is Duly Representative, to enter and Negotiate into a Memorandum Of Agreement with Marie Joy C. Siddayao - Owner and Operator of LJ Peryahan, and a Memorandum of Agreement between the Barangay Atulayan Sur and the Perya Owner, Marie Joy C. Siddayao.
5. The committee, sought that the following are documentary requirements for the approval to operate carnival;
  - a) Contract of Lease
  - b) List of Carnival Rides and Games
  - c) One (1) Affidavit of No Carnival Accident dully signed and notarized by the respective representative Municipality/City they operated in the past two (2) years (if they operated with carnival rides)
  - d) Barangay Clearance; and
  - e) BPLO application form for business permit
6. Other necessary documents identified by the BPLO must be complied and submitted upon securing Special Permit/Mayor's permit.
7. As per information from Hon. Virginia A. Tumaliuan, the following are the games in the carnival;

### **RECOMMENDATION:**


After thorough discussions, the committee members favorably recommend the passage of a resolution approving the conduct of Local Carnival (Perya) of Atulayan Sur in Celebration of its Patronal Fiesta, subject to the submission of all the documentary requirements and subject further to the following conditions;

For the Carnival Operator:

1. To secure a Special Permit/Mayor's Permit;
2. To maintain cleanliness and sanitation within the premises;
3. To secure and ensure the safety of the vicinity by providing security personnel;
4. Not to extend the time and days of operation;
5. To strictly comply with City Ordinance No. 80-08-2020, An Ordinance Prohibiting the use of Karaoke, Videokas and other similar Sound Producing Gadgets that disturb and disrupt Modular and On-Line Classes among Homes in the 49 Barangays of Tuguegarao City from Monday to Friday (7:00 AM to 7:00 PM) and Saturday (7:00 PM to 5:00 PM), and Providing Penalties for Violations thereof;
6. To strictly comply to City Ordinance No. 12-09-2023, An Ordinance Imposing Curfew Hours for Minors to Prevent Juvenile Delinquency and Providing Penalties thereof; with the exemption provided under Section 5 (3) Minors who are in the company of their parents, guardians and proper authorities;
7. To strictly observe health protocols within the premises; and
8. No consumption and selling of liquor within the vicinity.

Furthermore, the committee recommends that any form of illegal gambling activity, such as: Drop Ball, 6/8, Color Game and other similar illegal gambling activities inside the carnival shall be a ground for the termination/stoppage of their operations, revocation of their permit and will be subject to legal actions against the operator.

**DRAFT RESOLUTION APPROVING THE CONDUCT OF LOCAL  
CARNIVAL (PERYA) OF ATULAYAN SUR IN CELEBRATION OF  
ITS PATRONAL FIESTA**

**WHEREAS**, City Administrator, Mr. Juanito A. Calubaquib indorsed to the Tenth City Council on the request of Barangay Atulayan Sur relative to the conduct of amusement activity or perya to raise funds for their Annual Feast Celebration;

**WHEREAS**, the Committee on Games, Entertainment and Amusement to which the matter was referred, met and deliberated to discuss the subject referral with the presence of resource persons;

**WHEREAS**, the Punong Barangay of Atulayan Sur, Hon. Virginia A. Tumaliuan, mentioned the plan to establish a Local Carnival (Perya) at Zone 6, Cabalza Street, Atulayan Sur, Tuguegarao City, which will commence upon approval of the request and run until October 30, 2025 from 7:00 P.M. to 10:00 P.M. on Sundays to Thursdays, and from 7:00 P.M. to 11:00 P.M. on Fridays and Saturdays to further enliven the Barangay Patronal Fiesta celebration;

**WHEREAS**, the request to conduct peryahan will form part of their fund-raising activity in celebration of their Annual Patronal Fiesta;

**WHEREAS**, the approval of the conduct of Local Carnival (Perya) of Barangay Atulayan Sur shall be subject to the submission of the following documentary requirements:

- a) Contract of Lease;
- b) List of Carnival Rides and Games;
- c) One (1) Affidavit of No Carnival Accident dully signed and notarized by the respective representative Municipality/City they operated in the past two (2) years (if they operated with carnival rides);
- d) Barangay Clearance; and
- e) BPLO application form for business permit

**WHEREAS**, the conduct of the said Amusement Carnival (Peryahan) shall be subject, too, to the following conditions:

For the Carnival Operator:

1. To secure a Special Permit/Mayor's Permit;
2. To maintain cleanliness and sanitation within the premises;
3. To secure and ensure the safety of the vicinity by providing security personnel;
4. Not to extend the time and days of operation;
5. To strictly comply with City Ordinance No. 80-08-2020, An Ordinance Prohibiting the Use of Karaoke, Videokas and Other Similar Sound Producing Gadgets that Disturb and Disrupt Modular and On-Line Classes Among Homes in the 49 Barangays of Tuguegarao City from Monday to Friday (7:00 AM to 7:00 PM) and Saturday (7:00 AM to 5:00 PM), and Providing Penalties for Violations thereof;
6. To strictly comply to City Ordinance No. 12-09-2023, An Ordinance Imposing Curfew Hours for Minors to Prevent Juvenile Delinquency and Providing Penalties Thereof: with the exception provided under Section 5(3) Minors who me in the company of their parents, guardians and proper authorities;
7. To strictly observe health protocols within the premises; and
8. No consumption and selling of liquor within the vicinity.

**WHEREAS**, the committee further recommended that any form of illegal gambling activity such as Drop Ball, 6/8, Color Game and other similar illegal gambling activities inside the carnival shall be a ground for the termination/stoppage of its operations, revocation of its permit and will be subject to legal actions against the operator.

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve the conduct of Local Carnival (Perya) by Atulayan Sur in Celebration of its Patronal Fiesta.
