

RESOLVED FURTHER, to furnish a copy of this resolution to Tuguegarao City FUTSAL Team (Secondary Category) for their information.


On motion of Hon. Chan and without any objection, **CITY RESOLUTION NO. 433-09-2024** was **APPROVED** under suspended rules.
