WHEREAS, the Cagayan Valley Regional Association (CAVRAA) Meet is an annual sports competition spearheaded by the Department of Education-Region 02 participated by students and pupils from elementary and secondary levels in public and private educational institutions;

WHEREAS, this annual sports competition aims to:

- Provide students opportunities for participation in a well-managed sport competition in order to foster self-discipline, teamwork, excellence and other values inherent in the practice of sports.
- Promote sports to develop the physical fitness and health of students.
- Educate young people through sports in the spirit of better understanding and friendship to help build a strong, healthy and peaceful Region 2.
- Determine the champions in the different sport events in order to identify and train talented athletes who will represent the Region in various National competitions.

WHEREAS, on April 26-30, 2024, the CAVRAA Meet was held in the City of Ilagan and was attended and participated by athletes and delegates from the Provinces of Cagayan, Isabela, Batanes, Nueva Vizcaya and Quirino, and the Cities of Ilagan, Cauayan, Santiago and Tuguegarao of Region 2;

WHEREAS, the **SCHOOL DIVISION OFFICE OF TUGUEGARAO CITY** sent a total of 638 delegates comprising of 248 elementary athletes, 343 secondary athletes, 46 Technical Working Group Personnel (coaches, assistant coaches, trainers, medical personnel and representatives from School Division Office of Tuguegarao City) and other supporting staff who proudly represented Tuguegarao City;

WHEREAS, the Team Tuguegarao City garnered 52 gold medals, 39 silver medals and 53 bronze medals with a total of 144 medals in the different contested sports events during the 2024 CAVRAA Meet;

WHEREAS, the Tuguegarao City Government commends the determination, dedication, resilience and competitiveness of Tuguegarao young athletes as they vied for sports excellence, honor and glory in the 2024 CAVRAA Meet.



RESOLVED FURTHER, to furnish a copy of this resolution to School Division Office of Tuguegarao City for their information.


